Also announced this week was the development of a blood test which can identify the virus in AIDS victims, as well as prevent the transmission of AIDS by

blood transfusion.

The causative virus identified by the U.S. research team is known as HTLV-III and is thought to be related to the T-cell leukemia virus

The Pasteur Institute in Paris identified the virus as LAV, scientifically known as lymphyadenopathy-associated retrovi-

In the wake of the recent discoveries, scientists feel that a vaccine for the killer syndrome, which destroys the body's immunological system and leaves it open to a myriad of diseases, may be just on the horizon, possibly as soon as two years from now. But skeptical sciencists feel that it will take much longer for the vaccine to be developed.

### **Court of Appeals Hears** Oral Arguments on 21.06

NEW ORLEANS-The Fifth Circuit Court of Appeals heard the arguments for and against the "unconstitutionality" of Section 21.06 of the Texas Penal Code on Tuesday, April 17, but it could be severa months before a decision is handed down

Section 21.06, commonly referred to as the "homosexual conduct" law, was originally brought to court by the Texas Human Rights Foundation and Dallas

Human Rights Foundation and Dallas gay activist Don Baker. The law made certain sexual acts illegal between two consenting adults in private.

In the trial of Baker vs. Wade (Henry Wade, Dallas District Attorney), U.S. District Court Judge Jerry Buchmeyer determined that Section 21.06 was

unconstitutional.

Buchmeyer's decision was originally appealed by Governor Mark White, who was Attorney General at the time. How-ever, White's successor in the Attorney General's office, Jim Mattox, chose to drop

When Mattox dropped the appeal, Potter County District Attorney Denny Hill, funded by a group calling itself Dallas Doctors Against AIDS (DDAA), picked up

In the Appeals Court hearing, DDAA lawyer Rod Stakely began by stating that Don Baker had "no standing" or no right to contest Section 21.06. Stakely said that because Baker had not been arrested, threatened with arrest, or had not lost a job because of the statute, he did not have a right to contest it.

Attorney Charles Bundren, represent-ing Hill and DDAA, contended that the law did not represent a violation of the

"right to privacy."

Bundren cited the case of Doe vs. Com monwealth's Attorney, which contested the Virginia sodomy law. Bundren said that the Supreme Court ruled in the case that there was no right to engage in pri-

vate homosexual conduct.

Said Bundren, "The District Court should have followed the ruling in Doe vs. Commonwealth's Attorney—there is no right to privacy to engage in private homosexual conduct. No court has ever decided that the right to privacy extends to homo-

Bundren explained that the right to pri-vacy extended only to the home, marriage, family, procreation and child-rearing. "There cannot be a right to privacy for

Bundren claimed, "Section 21.06 was not a status statute. It regulates conduct and specifically defines conduct. This sta-tute is neutral on its face. It applies to any person. In the trial of Baker vs. Wade (Henry Wade, Dallas District Attorney), U.S. District Court Judge Jerry Buchmeyer determined that Section 21.06 was unconstitutional.

The Fort Worth Livestock Show and Rodeo might be bigger and the Huntsville Prison Rodeo just may be tougher, but the Texas Gay Rodeo promises to be more fes-

# Tarzan of the Wimps' or 'I'm An Actor—I'll PLAY Hunky'

By Steve Warren

The last actor who disillusioned me the way Christopher Lambert does was Eric Roberts. After drooling over the King of the Gypsies poster for weeks and being turned on by his presence in that other-wise lamentable film, I couldn't believe the short, slight, stuttering young man introduced as Roberts could be the same

It's almost the same with Lambert, the It's almost the same with Lambert, the new "Tarzan" of Hugh Hudson's Greystoke: The Legend of Tarzan, Lord of the Apes. Seeing him in pale person looking shorter than the six feet he claims, one is hardly reminded of the godlike bronzed beauty who swings through the trees in what purports to be the first film version of Tarzan of the Apes that is true to Edgar Rice Burroughs' original novel. The hyp-Rice Burroughs' original novel. The hyp-notic blue eyes are the same, but the rest of the face looks like Jean-Paul Belmondo's ("It's the mouth," he says, having heard this before) than the young Stewart Granger he resembles on screen.

Born in New York 27 years and one day

before Greystoke's March 30 nationwide opening ("It's the biggest birthday present ever!"), Lambert was raised in Geneva, Switzerland, for 16 years by his French parents. His father had an important Uni-ted Nations post. His name should be pro-nounced "lahm BARE," but his contract calls for him to use the English pronunciation in English-speaking countries.

After working six months on the Lon-

After working six months on the London Stock Exchange to please his father, Christoper—never "Chris" and he thinks "Christophe" sounds too pompous—entered Paris' Conservatorie to get training and experience as an actor.

Aside from stage work, he appeared in a couple of French films, the sort of policiers that do big business at home but are rarely exported to the U.S. He says he played "a young gangster" in both: "In France, a young actor of 22 or 23 has two choices. He can play a young gangster or a young

The Conservatorie fired Lambert after two years, freeing him to audition for Hugh Hudson, who was casting for Greys-toke in Paris. "I believe in destiny," the young actor says about the timing. The audition was an unusual one: "He (Hud-son) just looked at me for half an hour without saying a word.

That half-hour convinced the director, flushed with the success of Chariots of Fire, that Lambert's eyes had it, an important consideration for an actor who won't utter a human sound for more than an hour of the film. "You can change everything else, but you can't change the eye There was something about him that came off as wild...innocent."

Tarzan's innocence is a question the film overlooks; but since we don't have to worry about a "PG" rating, we ask if he wouldn't have lost it among the apes as he was growing up. "If you mean his sexual innocence, yes," Hudson confirms. "In another book (of Burroughs' series), he falls in love with a she-ape.

Hudson prefers to regard innocence in a Hudson prefers to regard innocence in a broader sense, comparing Tarzan to Adam. In his Eden, "D'Arnot (the Belgian sea captain played by Ian Holm who intrudes on behalf of civilization) is the serpent, if you look at it that way

Considering that previous screen Tar-zans have been drawn from the ranks of professional athletes rather than actors, Hudson's casting approach was radical. "I wasn't in good shape," Lambert admits,

puffing on a cigarette.
Six months of rigorous training—"For the first months, I wanted to kill my trainer"—got him into shape. He studied "gymnastics—no weight lifting— 'chimping' and English." The director, another smoker, didn't try to make his star quit-"because of the nervous effect,

Lambert says.
"Chimping" was studied even more intensively by the 21 actors, dancers and/or stunt persons who play primates

in the film. They mingled with real animals imported from London to the locations in Cameroon, equatorial West Africa. Hudson says it was sometimes as hard for him to tell the actors from the chimps as it will be for audiences who see Greystoke.

The director did three weeks of research at Dr. Roger Fouts' primate center near Seattle. He talks at length about the fasci-nating and important research in communications that goes on there, and puts in a plug for Fouts: "He desperately needs money. His grant's been taken away by

Lambert and Hudson learned that chimps are not always the lovable creatures we think them to be from watching the likes of Bonzo, J. Fred Muggs and Clint Eastwood's orangutan Clyde. "They are totally paranoid," the actor says. They can kiss you and then rip your arm off. They are five times stronger than a human being when they're five to nine years old." You shouldn't stand erect

# Tarzan of the Wimps' or 'I'm An Actor—I'll PLAY Hunky'

The last actor who disillusioned me the way Christopher Lambert does was Eric Roberts. After drooling over the King of the Gypsies poster for weeks and being turned on by his presence in that other-wise lamentable film, I couldn't believe the short, slight, stuttering young man introduced as Roberts could be the same

It's almost the same with Lambert, the new "Tarzan" of Hugh Hudson's Greystoke: The Legend of Tarzan, Lord of the Apes. Seeing him in pale person looking shorter than the six feet he claims, one is hardly reminded of the godlike bronzed beauty who swings through the trees in what purports to be the first film version of Tarzan of the Apes that is true to Edgar Rice Burroughs' original novel. The hyp-It's almost the same with Lambert, the Rice Burroughs' original novel. The hyp-notic blue eyes are the same, but the rest of the face looks like Jean-Paul Belmondo's ("It's the mouth," he says, having heard this before) than the young Stewart Granger he resembles on screen.

Born in New York 27 years and one day

before Greystoke's March 30 nationwide opening ("It's the biggest birthday present ever!"), Lambert was raised in Geneva, Switzerland, for 16 years by his French parents. His father had an important Uni-ted Nations post. His name should be pro-nounced "lahm BARE," but his contract calls for him to use the English pronuncia-

tion in English-speaking countries.

After working six months on the Lon-After working six months on the London Stock Exchange to please his father, Christoper—never "Chris" and he thinks "Christophe" sounds too pompous—entered Paris' Conservatorie to get training and experience as an actor.

Aside from stage work, he appeared in a couple of French films, the sort of policiers that do big business at home but are rarely exported to the U.S. He says he played "a young gangster" in both: "In France, a young actor of 22 or 23 has two choices. He can play a young gangster or a young

The Conservatorie fired Lambert after two years, freeing him to audition for Hugh Hudson, who was casting for *Greys-toke* in Paris. "I believe in destiny," the young actor says about the timing. The audition was an unusual one: "He (Hud-son) just looked at me for half an hour without saying a word.

That half-hour convinced the director. flushed with the success of Chariots of Fire, that Lambert's eyes had it, an important consideration for an actor who won't utter a human sound for more than an hour of the film. "You can change everything else, but you can't change the eye There was something about him that came off as wild...innocent."

Tarzan's innocence is a question the film overlooks; but since we don't have to worry about a "PG" rating, we ask if he wouldn't have lost it among the apes as he was growing up. "If you mean his sexual innocence, yes," Hudson confirms. "In another book (of Burroughs' series), he falls in love with a she-ape.

Hudson prefers to regard innocence in a Hudson prefers to regard innocence in a broader sense, comparing Tarzan to Adam. In his Eden, "D'Arnot (the Belgian sea captain played by Ian Holm who intrudes on behalf of civilization) is the serpent, if you look at it that way

Considering that previous screen Tar-zans have been drawn from the ranks of professional athletes rather than actors, Hudson's casting approach was radical. "I wasn't in good shape," Lambert admits,

puffing on a cigarette.
Six months of rigorous training—"For the first months, I wanted to kill my trainer"—got him into shape. He studied "gymnastics—no weight lifting— 'chimping' and English." The director, another smoker, didn't try to make his star quit-"because of the nervous effect,

Lambert says.
"Chimping" was studied even more intensively by the 21 actors, dancers and/or stunt persons who play primates

pics will last a few short weeks, the World Expo will be open from May 16 to Sept. 16.

Another big difference is that in New Orleans, there will be active participation of lesbians and gay men, as gay people in that city are planning the first Gay Pavilion ever opened in conjunction with a World Expo or Fair.

The idea was the brain child of Roger Nelson, a member of the Crescent City Coalition, a gay political activist group founded in 1981, following an anti-gay police sweep in which 101 people were arrested. Nelson's idea was to set up a Pavilion in the French Quarter, the gay sector of New Orleans, which could be converted later into a gay community cultural and services center when World Evro. '84 and services center when World Expo '84

The Crescent City Coalition took to the idea enthusiastically and "Stone-wallo15," an alternate exposition, became a project of the organization. With the backing of local gay businesspeople, they have leased a 17,000 square foot, two-story building with high ceilings and large open spaces. They are now in the process of outreaching to the entire American gay community to become involved in planning and contributing to the permanent and changing exhibits, and the four month long program of events.

Nelson said that the main grounds of the World Expo is located along the Mis-sissippi River, a distance of seven blocks from the French Quarter, a section of town that no visitor to New Orleans ever misses. Fifteen countries had already agreed to construct exhibition buildings when Nelson's idea was triggered by the ground breaking of the black and women's pavilions. Why not us, he thought, and why not something that will continue to live on. Nelson said 11 to 12 million visitors are expected to visit Louisiana World ity for our people to tell them about our-

selves.
"The Stonewalló15' exhibits will be "The Stonewallol5' exhibits will be entertaining as well as educational, illustrating our lifestyles and reflecting the best of gay people, illuminating our past, present and expectations of for the future," said Nelson.





## Presidential Hopefuls Respond to NGTF's Questionnaire



A coalition of five national gay/lesbian organizations released a summary of the responses by Presidential candidates to a questionnaire that covered a range of issues of concern to the lesbian and gay community. The questionnaire was sent to candidates as part of "84 and Counting," the nationwide voter registration and edu-cation drive co-sponsored by the National Gay Task Force, the National Association of Gay and Lesbian Democratic Clubs, the National Coalition of Black Gays, the Human Rights Campaign Fund and the Gay Rights National Lobby.

Of the 11 candidates who were sent the

Of the 11 candidates who were sent the questionnaire, eight responded—Democrats Alan Cranston, Gary Hart, Ernest Hollings, Jesse Jackson, George McGovern and Walter Mondale; Sonia Johnson of the Citizens Party; and Libertarian David Bergland.

Democrats Reubin Askew and John Glenn and Republican Ronald Reagan failed to respond to the questionnaire.

Askew, Glenn, McGovern, Cranston and Hollings have since withdrawn from the Presidential race.

Civil Rights. All of the respondents except Bergland indicated that they would support passage of some kind of gay/lesbian civil rights bill. Jackson, Johnson and McGovern specifically supported the pending House bill (H.R. 2624), which covers employment, housing and public ers employment, housing and public accommodations, while Cranston and Hollings noted that they are co-sponsors of the Senate bill (S. 430), which covers employment only. Hart and Mondale supported the concept of a civil rights bill but stopped short of endorsing specific legisla-tion. However, since answering the questionnaire, Mondale has publicly endorsed S.

All except Bergland responded postively to the suggestion that government civil rights agencies should include antigay/lesbian bias in their mandates, and that anti-lesbian/gay violence should be classified as a civil rights violation. Government Employment. One of

the most noteworthy results of the questi-onnaire was the fact that every respond-ent but Hollings said that he or she would issue some kind of executive order ban-ning discrimination based on sexual orientation in federal employment. Each of those candidates, except Bergland, indi-cated that such an order would extend to federally contracted private employment. (Hollings' answer was positive but not

On the still more controversial issue of including military and security agencies in an executive order, Hart and Mondale parted company with the others, who asserted that they favored such a move.

Said Hart, "In the case of military employment, recent court cases have upheld the right of the armed forces to limit employment on the grounds of sex-ual orientation. The rationale for restrictions on military employment have generally revolved around the possibility generally revolved around the possibility of blackmail and a consequent risk to national security. A citizen's desire to serve the country should be honored unless the courts have deemed otherwise or the citizen is not willing to abide by a code of conduct applied equally to all military personnel. Military employment should not be restricted because of sexual orientation per se."

Mondale's response was, "I have yet to this ban to uniformed personnel (and) the

"Traditionally," Mondale continued,
"the security field has sought to minimize
the vulnerability of its members to blackmail. On occasion, its attempts to do so come into conflict with the civil rights of lesbians and gay men who apply for posi-tions in this field. As President, I would establish a commission to investigate the merits of current Administration policy in this regard and make recommendations to resolve any civil rights conflict in this pol-

Immigration. On the issue of immigration reform, all candidates indicated support for legislation to eliminate exclusions based on sexual orientation. All but Mondale said they would direct the Justice Department not to contest court challenges to existing law; the former Vice President responded that as President, "it would be my duty to enforce the laws, not to make them (a power which belongs to Congress) or to definitely interpret them (a power which resides in the Supreme court)."

Women's Issues. Issues of special concern to women brought unanimity among the candidates, all of whom vowed to use the power of the Presidency to support passage of the Equal Rights Amendment, supported freedom of choice on abortion, and opposed any attempt to limit that right for all women, including denial of Medicaid funds to poor women seeking

Health Care. In the wake of the AIDS

epidemic, all of the candidates said they would support efforts to make the nation's health care system more responsive to public health emergencies, and to ration-alize and improve health care programs and social service benefits for individuals facing major health care costs. Except for Bergland, they supported efforts to address the special health care needs of minority communities in federal programs, and said they would support spe-cific measures to deal with AIDS-associated catastrophic health

## Presidential Hopefuls Respond to NGTF's Questionnaire



A coalition of five national gay/lesbian organizations released a summary of the responses by Presidential candidates to a questionnaire that covered a range of issues of concern to the lesbian and gay community. The questionnaire was sent to candidates as part of "84 and Counting," the nationwide voter registration and edu-cation drive co-sponsored by the National Gay Task Force, the National Association of Gay and Lesbian Democratic Clubs, the National Coalition of Black Gays, the Human Rights Campaign Fund and the Gay Rights National Lobby.

Of the 11 candidates who were sent the questionnaire, eight responded—Democrats Alan Cranston, Gary Hart, Ernest Hollings, Jesse Jackson, George McGovern and Walter Mondale; Sonia Johnson of the Citizens Party; and Libertarian David Bergland.

Democrats Reubin Askew and John Glenn and Republican Ronald Reagan failed to respond to the questionnaire.

Askew, Glenn, McGovern, Cranston and Hollings have since withdrawn from the Presidential race.

Civil Rights. All of the respondents except Bergland indicated that they would support passage of some kind of gay/lesbian civil rights bill. Jackson, Johnson Of the 11 candidates who were sent the

bian civil rights bill. Jackson, Johnson and McGovern specifically supported the pending House bill (H.R. 2624), which covers employment, housing and public accommodations, while Cranston and Hollings noted that they are co-sponsors of the Senate bill (S. 430), which covers employment only. Hart and Mondale supported the concept of a civil rights bill but stopped short of endorsing specific legisla-tion. However, since answering the questionnaire, Mondale has publicly endorsed S.

All except Bergland responded postively to the suggestion that government civil rights agencies should include antigay/lesbian bias in their mandates, and that anti-lesbian/gay violence should be classified as a civil rights violation. Government Employment. One of

the most noteworthy results of the questi-onnaire was the fact that every respond-ent but Hollings said that he or she would issue some kind of executive order ban-ning discrimination based on sexual orientation in federal employment. Each of those candidates, except Bergland, indi-cated that such an order would extend to federally contracted private employment. (Hollings' answer was positive but not

On the still more controversial issue of including military and security agencies in an executive order, Hart and Mondale parted company with the others, who asserted that they favored such a move.

Said Hart, "In the case of military employment, recent court cases have upheld the right of the armed forces to limit employment on the grounds of sex-ual orientation. The rationale for restrictions on military employment have generally revolved around the possibility generally revolved around the possibility of blackmail and a consequent risk to national security. A citizen's desire to serve the country should be honored unless the courts have deemed otherwise or the citizen is not willing to abide by a code of conduct applied equally to all military personnel. Military employment should not be restricted because of sexual orientation per se."

Mondale's response was, "I have yet to reach a decision concerning extension of this ban to uniformed personnel (and) the

security agencies."
"Traditionally," Mondale continued, "the security field has sought to minimize the vulnerability of its members to blackmail. On occasion, its attempts to do so come into conflict with the civil rights of lesbians and gay men who apply for posi-tions in this field. As President, I would establish a commission to investigate the merits of current Administration policy in this regard and make recommendations to resolve any civil rights conflict in this pol-

Immigration. On the issue of immigration reform, all candidates indicated support for legislation to eliminate exclusions based on sexual orientation. All but Mondale said they would direct the Justice Department not to contest court challenges to existing law; the former Vice President responded that as President, "it would be my duty to enforce the laws, not to make them (a power which belongs to Congress) or to definitely interpret them (a power which resides in the Supreme court)."

Women's Issues. Issues of special concern to women brought unanimity among the candidates, all of whom vowed to use the power of the Presidency to support passage of the Equal Rights Amendment, supported freedom of choice on abortion, and opposed any attempt to limit that right for all women, including denial of Medicaid funds to poor women seeking

Health Care. In the wake of the AIDS

epidemic, all of the candidates said they would support efforts to make the nation's health care system more responsive to public health emergencies, and to ration-alize and improve health care programs and social service benefits for individuals facing major health care costs. Except for Bergland, they supported efforts to address the special health care needs of minority communities in federal programs, and said they would support spe-

cific measures to deal with AIDS-associated catastrophic health Costs. All but Bergland, McGovern and Mondale specifically stated that they favored funding the Public Health Emer-gency Fund. 


