It is therefore considered by the Court that the plaintiff recover of the defendants as executors and executrix as aforesaid the said sum of two thousand six hundred and seventy nine  $\frac{34}{100}$  dollars, together with all his costs in this behalf expended, and that said claim of said plaintiff be established and ranked amongst the acknowledged claims of said estate of said Sanford Holman deceased, without out execution from the Court.
