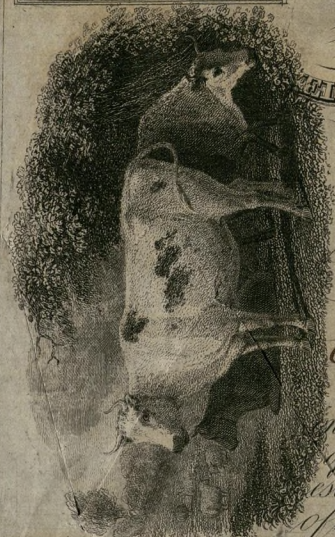

 with interest at the rate of eight percent per annum from date hereof, payable semi-annually
 on the first days of January and July at the Treasury Department in Gold or Silver on presentation
 of this Certificate, and delivery of the proper coupon hereto annexed, the first payment of inter-
 est to be made on the first day of July, 1864. The principal redeemable at the pleasure
 of the Government, after the first day of January, 1866. This certificate, including the
 installments of interest which may have become due, shall at all times be receivable in
 Collection of the Revenue, and in the payment of any dues to the Government, the Revenue
 from License Tax and Tax on Personal Property is set apart and specially appro-
