Thus far, the unhappy prospect is for the same personalities to make and break the same promises so glibly held out in 1952 which led the majority of the American electorate to believe that we were headed back toward Constitutional government.

The party machinery of both the Republicans and Democrats still rests in the hands of international bosses who dictate Presidential nominees of each and who pour millions of dollars into the two campaign chests with complete impartiality and total unconcern as to which one wins, so long as the policies of an invisible super-government are carried out by the successful contestant.

That is why, out of a total population of more than one hundred million adults, including many of unquestioned qualifications for patriotic and intelligent leadership, only those are being considered by the stooges of the international bosses for a place on both tickets who will continue to stultify the Constitution, surrender American sovereignty through treaties and executive agreements and drain off the substance of American taxpayers to replenish the treasuries of impoverished foreign Socialist States.

Americans have now learned the hard way that the so-called bipartisan foreign policy means nothing more nor less than the repudiation of the differing principles which once distinguished the Republican and Democratic parties as separate entities with divergent views on important issues, and their gradual merging into one vast international Socialist Party with world government as their common objective. That this ultimate aim has not already been achieved can only be credited to the protecting hand of a Divine Creator who tempers the wind to the shorn lamb and who likewise secures a Christian Republic against assaults by its enemies from without and within.

The debt-burdened, economically and militarily-disturbed State of the Union today in which global demands for men and money is constant and perpetual, stems from the refusal of national leaders to heed the advice of experienced statesmen of an earlier day who warned that we would be courting disaster if we mixed in the affairs of foreign nations who had been squabbling and fighting each other from the beginning of history and would continue until the end of time.

Millions of Americans Think It-The Southern Conservative Says It

One Explanation of the Flood of Subversive Propaganda Which Is Deluging United States

When patriotic Americans ask in anguished alarm why there is so much subversive propaganda for a one-world government to supersede our beloved Republic, there is no answer or rather there are too many answers to be incorporated into one concrete and correlated reply.

There are so many groups, organizations and movements seeking to undermine our form of government and way of life that it would be easier, perhaps, to name the innocent than to enumerate the guilty.

For instance, all over the United States every day of every week of every month of every year activities are carried on by certain segments of our society who stand high in public esteem that are designed to undermine established and cherished American principles, customs and traditions and to bring about the acceptance of a one-world totalitarian system as a replacement for our Constitutional government.

As one of the thousand examples of this sort of activity, the Texas Council of Churches in its News Letter of March, 1956, tells of a "workshop" for "community education" which is to bring about understanding of problems in a "world order." This "workshop" will be held at Austin in the University Methodist Church April 17 and will be called "The Texas Workshop on the Churches and World Citizenship." On the face of it, that doesn't sound so bad but attend one of these "workshops," note who their speakers are, listen to what they have to say, and read the literature they put out and part of the answer to the above question will be made clear. These State Councils of Churches are a division of the parent organization, the National Council of Churches which demands recognition of Red China, the sabotaging of our immigration law, the suppression of all investigations into Communism and advocates mongrelization of the white Christian race in the United States through integration.

A sub-committee of the Texas Council of Churches' "Christian Social Relations Committee" is reported in this same News Letter to have met in San Antonio recently "to form suggested questionnaires for use of local organizations in qualifying candidates for the State Legislature," a very peculiar activity on the part of groups who strongly stress separation of Church and State.

In this same News Letter there is notice of three "weekend retreats" to which carefully screened "influential public school administrators or teachers" will be invited all of whose expenses will be paid by the Council except transportation. "Top educational authorities and scholarly clergymen will give the teachers a deeper concept of their tasks," the News Letter adds.

Since when has it become the function of church groups to select public school administrators and teachers and tell them what to teach in our schools and who authorized them to give a post-graduate course in education to paid employees of tax-supported public schools of Texas?

And will these "top educational authorities" and these "scholarly clergymen" who propose to "give teachers a deeper concept of their task" impress on these teachers the constant threat of Communist infiltration into their profession and advise them to fight this deadly menace with all their might and resources? Will they plead with these teachers to remain firm in their faith in the American form of government and its Constitution and undertake to transmit this faith to the students in their charge?

Will they explain to these teachers and administrators whose expenses they are going to pay, that the highest type of Christian morality on the part of an American educator consists in his undeviating loyalty to his country, allegiance to its flag and unqualified support of the Christian principles underlying the American Free Enterprise System and its matchless record in building a Republic of unsurpassed prosperity and freedom of the individual not found in any other country on the globe?

We think not and if the people of Texas, and any other State where similar activities are carried on, will make it their business to learn what goes on at such gatherings, they will get a much clearer understanding of why this country is swamped with propaganda for the abolishment of the American Republic in favor of a totalitarian world state.

Labor Board Hired Hands Defy Committee A La Stassen

We predict that, sooner or later, the American people are going to become fed up to here with the cute little custom of withholding information from the people to which they are entitled, which is becoming a favorite indoor sport in Washington.

Beginning in the White House where practically everything except information about the weather is classified as "top secret" and not to be divulged to the vulgar public, the practice is spreading to other agencies.

Following the refusal of Harold Stassen to answer questions of a senate sub-committee concerning a secret meeting in Paris in 1954 where Russia was permitted to increase its purchase of strategic materials, eight employees of the National Labor Relations Board pulled the same disgusting stunt.

Summoned to testify before the House Committee on Un-American Activities, they presented Chairman Francis Walter with letters of instruction from their Board instructing them not to testify about loyalty-security data.

Chairman Walter very justifiably blew up and termed this interpretation of Eisenhower's Executive order of May 17, 1954 "incredibly stupid and designed to frustrate all Congressional inquiries into government subversion."

It is worse than that and it indicates that the dictator complex in Washington is becoming more pronounced, and emphasizes the need for a thorough house-cleaning in the nation's capital.

At a Negro Community center, white and Negro teenagers were brought together through the ministrations of a white Methodist church to discuss "subject matter on integration from the problems encountered in school to the possibility of intermarriage."

One white teenage girl blithely expressed the opinion that teenagers don't really care as they "do not have the prejudices of their parents" indicating how thoroughly she has learned to parrot the Red propaganda fed to youngsters in American schools, and churches.

The discussion was led by a white assistant pastor of one of the local Methodist churches.

In one of the public schools a "mock trial" was held in which the youngsters "tried" their parents for the crime of instilling "prejudice" in their minds from early infancy. A local district judge actually sat in on the "trial" and delivered a verdict.

To give them credit, we do not believe that either the officials of this particular school, those participating in the farce or the students realized that they were being used in a propaganda campaign by a certain group which is doing the same thing all over the country, and bragging about it.

It will be remembered that something of this sort was employed by Hitler who urged children to inform on their parents and the same idea is current in Russia where it is all in the day's work for youngsters to turn in their parents when they waver in their loyalty to the party.

If any further project along this line is attempted, it is to be hoped that higher school authorities will put their foot down before the thing spreads any further.

The vast multitude of disillusioned and disgusted Americans who are demanding the change in 1956 that they voted for in 1952, can no longer be laughed off as crackpots and rabble-rousers since many of the most astute political figures in the nation are joining the swelling throng clamoring for an end to our role as an International Santa Claus and a return to Constitutional government in the United States.

For years we have steadfastly maintained that a third party was a futile gesture from the standpoint of practical political considerations and we still feel that the answer is not in deserting the two once great major political parties but in rescuing them from the hands of those who have perverted and despoiled them. Surely the American people who have never failed in dire emergencies from Valley Forge to Corregidor, will find some effective way to reclaim one or both from the corrupt international forces who hold them captive.

Proponents of a new party, with some validity, advance the argument that since we now have only one party composed of irreconcilable liberals, one-worlders, internationalists and pro-Communists, the setting up of another would merely add a Conservative Party to the one Socialist Party now in existence, and that its classification as a third party would be an incorrect designation.

The best thought, however, of leaders of the dissenting millions who have indicated that they will stay home rather than vote for any candidate now proposed, is that if each State will concentrate on its electors and select only those who are known to favor the preservation of our national sovereignty, the financial solvency of the Republic and a return to Constitutional government, these electors, in conscience, can only cast their State's vote for a pro-American rather than for any of the internationalists so far paraded as the choice of both parties.

As Americans, we like to boast that ours is an independent electorate and that we have free choice in naming candidates for President and the 1956 election will give us the ideal chance to prove whether we do in fact enjoy free elections or whether the coalition of the two parties has reduced us to the status of the Russian slave state and compelled us to accept one of the two candidates who have been chosen for us by international conspirators against the safety and security of the United States.

Observance of the Birth of Christ and Singing of Our National Anthem by School Children May Be Barred by Law

If the time should come—God forbid—when the Communists take us over as they have in the case of other countries, they will find one State in the American Union where the stage is all set for them and the ground-work laid for the take-over, with little adjustment necessary to bring about total conformance to Soviet procedure.

That State is the Commonwealth of New Jersey where a measure known as the Anti-Discrimination law of 1945 is in operation with the State Commissioner of Education—of all people—legally functioning as a virtual dictator empowered with authority that is un-heard of in the history of the forty-eight States which compose the American government.

This authority includes the right of the State Commissioner of Education to exercise police power over all individuals, corporations, employment agencies and other units in the hiring of workers, permits him to ignore the "strict rules of evidence prevailing in courts of law or equity" in holding hearings, and strikes down the fifth amendment to the Constitution of the United States in the case of witnesses who may wish to testify in their own defense.

Above and beyond exercising his wide scope of authority in policing employment practices in that State, recent happenings there clearly indicate that the Commissioner of Education intends to invoke the provisions of this law to make it illegal for public school children of New Jersey to take part in any school program based on Christianity on the ground that this is "discrimination".

Although this law has been on the statute books of New Jersey since 1945, with later amendments, little was known of it outside that State until December 6, 1955, when the superintendent of the Sayreville, New Jersey, public schools issued an extraordinary bulletin to the school principals there.

In this bulletin the Superintendent, Dr. Richard S. Pollock, a member of the American Association

of School Administrators, a department of the National Education Association advised the principals:

"The purpose of this bulletin is advisory. We are told by the State Department in charge of enforcing the anti-discrimination statutes, that there is a growing feeling in various parts of the State with respect to the celebration of Christmas by special observances and exercises in the public schools. While this is not yet a situation that could be characterized as a problem, it is one that is growing and which will require our attention in the near future. It might, therefore, be wise to be somewhat beforehand in this respect with the end in view of lessening the impact in this community if, when and as the situation becomes official.

"At this time, no specific action is indicated but it may be wise to consider, beginning at once, how the Christmas program to be offered in your school could be re-planned so as to deemphasize the sectarian religious aspect thereof and to emphasize instead the folk lore value. As an illustration, it may be possible to substitute such folk songs as "Deck the Halls with Holly" for one of the more religious type songs which are generally used. It is the opinion of your Superintendent that within the foreseeable future, say the next 3 to 10 years, it will be required by the courts that the specifically religious aspect of the celebration be deleted from public school programs and that it will become illegal to use some of the hymns and anthems that are now quite common and that it will be necessary to avoid pageants involving the nativity, angels and similar props. It is suggested that it might be well to begin to re-plan this program in this direction so that the change-over is so gradual as to be unnoticeable to the general public over a period of years. Signed R. S. Pollack".

With the exception of correcting two of his mis-spelled words, the above is an exact quotation from this School Superintendent who appears to have advance information on plans of World Conspirators

against the United States to stamp out Christianity in this country, beginning at school-age level, by making observances of the Birth of Christ illegal and to obliterate all traces of patriotism for their own country by denying school children the right to sing the National Anthem.

When this atheistic document from the Sayreville School Superintendent fell into the hands of Christians outside the State of New Jersey recently, efforts were made to find out his authority for suggesting the abolishment of sacred and age-old symbols of Christianity and patriotism in American public school programs.

It was found that he was acting under instructions from the State Commissioner of Education of New Jersey, Frederick M. Raubinger, who happens to have been the chairman of the New Jersey delegation to the recent White House Conference on Education in Washington.

Although the Anti-Discrimination Law of 1945 of the State of New Jersey does not specifically list the Birth of Christ and observance of the event and the singing of our National Anthem as "discriminations" against the sovereign citizens of New Jersey, there is sufficient latitude in its provisions evidently to permit this assumption and the State Commissioner of Education is obviously planning to use it to that end.

The law, in its own words, purports to be an act authorizing the "exercise of the police power of the State for the protection of the public safety, health and morals" and to guarantee "civil rights" to the people of New Jersey, and bears down on the Communist-inspired phrase which has now become routine in all enactments "without discrimination because of race, creed, color, national origin or ancestry".

Acts regarded as "discrimination" are handled under the "Division Against Discrimination of the Department of Education" which the law sets up under the direction of the Commissioner of Education and authorizes him to issue subpoenas to any one he regards as having engaged in "un-

lawful employment practice" compels them to produce "records, correspondence, documents or other evidence in obedience to the subpoena of the Commissioner..." and "no person shall be excused from testifying on the ground that the testimony or evidence required of him may tend to incriminate him", and the Commissioner shall "not be bound by the strict rules of evidence prevailing in the courts or equity".

Although it is an act claimed to be set up to "protect the public safety, health and morals" of the people of New Jersey nowhere is there any definition of the qualification of applicants for jobs who may be regarded as being "discriminated" against in the event they are refused employment. In practical application it could work out this way: a qualified white man and an incompetent Negro man could apply for the same job. If the white man were hired and the Negro turned down, the employer could be in violation of a law designed to "protect the public safety, health and morals" of the State.

That this law is ultimately to be used in attempts of certain groups throughout the world to stamp out Christianity in the United States has been proved by the Sayreville Superintendent of Public Schools in his communication to local principals although it is doubtful if even the Socialists, one-worlders, mongrelizers and other subversive elements who wrote it and passed it through the New Jersey legislature realized that it would eventually become the implement for striking down the Christian faith and patriotism of future citizens of that great State.

In brief, this Anti-Discrimination law which now disgraces the statute books of the State of New Jersey is a miniature Genocide, UNESCO and Human Rights covenant all rolled into one and in the event of Soviet invasion, all the officials of that State will have to do is move over and let the Communists crawl in bed with them.

A Skunk by Any Other Name Smells Just as Bad

The National Citizens Commission for the Public Schools has fooled no one by changing its name to the National Citizens Council for Better Schools.

Its objectives will remain the same and its close affiliation with the National Education Association will be unchanged.

It will still seek to indoctrinate lay people with the virus of Progressive Education, Federal Aid to Schools, integration of white and Negro schools, United Nations and UNESCO propaganda for one-world government.

It is merely following the course of the Southern Conference for Human Welfare, the Federal Council of Churches and other groups which became so notoriously left-wing, if not subversive, that they were forced by outraged public opinion to change their name to remove the odor.

Congress of Freedom To Meet in Dallas

A call for their annual meeting has been issued by the Congress of Freedom from its headquarters in Omaha, Nebraska, to be held at Dallas, April 5, 6 and 7th at the Adolphus Hotel.

According to the announcement, people will be there who "believe in the United States, and who are trying to point the way back to solvency, freedom, sanity".

There is usually an amusing angle to everything, no matter how serious. Voice of Early American President Whispers A Warning From Grave

Franklin Pierce who was inaugurated President of the United States on March 4, 1853, was never singled out by history as a particularly great statesman, but in his inaugural address he made observations which should class him among the immortals.

His words of warning uttered more than a hundred years ago are tragically appropriate in this good hour when the Federal government constantly seeks to usurp authority belonging to the States:

"The dangers of a concentration of all power in the general government of a confederacy so vast as ours are too obvious to be disregarded. You have a right, therefore, to expect your agents in every department to regard strictly the limits imposed upon them by the Constitution of the United States. The great scheme of our Constitutional liberty rests upon a proper distribution of power between the State and Federal authorities, and experience has shown that the harmony and happiness of our people must depend upon a just discrimination between the separate rights and responsibilities of the States and your common rights and obligations under the General Government; and here, in my opinion, are the considerations which should form the true basis of future concord in regard to the questions which have most seriously disturbed public tranquility. If the Federal government will confine itself to the exercise of powers clearly granted by the Constitution, it can hardly happen that its action upon any question should endanger the institutions of the States or interfere with their right to manage matters strictly domestic according to the will of their own people . . ."

Would to God this fundamental understanding of the American form of government could be pounded into the thick skulls of those in control of the executive, legislative and judicial branches of government, all of whom have repeatedly violated this organic law of the Republic.

Pointing out what could happen to our country if it departed from the wise provisions of the Constitution as formulated by the founders, President Pierce added in this same inaugural address:

"Let it be impressed upon all hearts that, beautiful as our fabric is, no earthly power or wisdom could ever re-unite its broken fragments. Standing, as I do, almost within view of the green slopes of Monticello, and, as it were, within reach of the tomb of Washington, with all the cherished memories of the past gathering around me like so many eloquent voices of exhortation from heaven, I can express no better hope for my country than that the kind Providence which smiled upon our fathers may enable their children to preserve the blessings they have inherited."

The Schools That Were to Be An 'Example for the Nation'

Officials of an "integrated" junior high school in Washington, D. C., are greatly disturbed over the disappearance of more than four hundred pieces of school cafeteria silverware since last September when the "noble experiment" in education was put into full effect, according to a Washington daily newspaper.

Worried teachers were faced with the proposition of either making students walk out on their hands as they left in the afternoon or removing temptation by locking up the silver and letting the pupils eat with their fingers.

They finally compromised by requiring each student to put up a cash deposit for his knife, fork and spoon each noon which is returned when the silverware is brought back to the cashier. It was revealed that the plan may have to be put into effect in other Washington schools.

The matter offers food for thought on the part of the "psychologists" who, with a Swedish Marxist, were called on to pinch-hit for the American Constitution when members of the Supreme Court decided to by-pass that great document in cooking up a weird arrangement for American school procedure.

Will children who have been taught that stealing is a crime be able to exert wholesome influence on offenders and bring them up to their level of honesty or will those who pilfer as instinctively and naturally as they breathe, convert the non-stealers to their way of life?

Heaven Protect Us From the Psychiatrists

It looks like the American people are going to have to take steps to protect themselves from the psychiatrists whose plans for acquiring control of the human mind are getting bolder by the hour.

According to the Los Angeles Examiner, January 9, 1956, Dr. Nicholas A. Berzel, a psychiatrist of Beverly Hills listed as a great advancement a new method of "inducing mental illness" in a normal person by the injection of something called "lysergic acid diethylamide" in order that mental specialists might experiment and study the results of this self-induced mental illness.

Thus, psychiatrists seem to consider their function not only to unscramble mixed-up minds but to deliberately latch on to a normal mind and louse it up in order to have a subject for experimentation in case a bonafide nut is not conveniently at hand to serve as a human guinea pig.

This, if we may be permitted to say so, seems to be going a bit far afield in the matter of mental research.

"I am convinced in my own mind that it is unconstitutional for American taxpayers' funds to be scattered over the world to support foreign nations but in view of the strained interpretations our courts are placing on constitutional questions, I do not have too much hope"—Governor Bracken Lee of Utah who is testing the matter in the courts or trying to. We really don't have courts for redress of wrongs any more.

An Ominous Sign

(The Fort Worth Star-Telegram)

One of the most chilling incidents yet to appear in the South's fight against desegregation of its public schools got only a paragraph in most newspapers, but it is deeply significant of the rapidly changing relationship between the white and Negro peoples themselves.

It was the clamorous and unanimous approval by the Alabama Senate of a resolution asking federal funds to move Negroes from Alabama to regions outside the South where they are "needed or wanted."

Naturally, no one in the Senate had any expectation that such funds would be made available, but the resolution nevertheless reflects a state of mind which is new and dangerous. Such a resolution would have been impossible even a year ago. White people and Negroes long have lived together in Alabama with more than tolerable harmony and in many cases genuine affection. No white Alabamian would have seriously advocated driving his Negro neighbors out of the state and out of the South. The Negro always has been considered as much a part of the Southern scene as the Dixie landscape itself.

Now comes the Senate of a Southern Legislature with an explosive, emotional demand for the Yankees to come and get him, for the South doesn't want him or need him. This is what happens when well-intentioned but misinformed people incite a quarrel between old friends. Of course the Alabama Senate doesn't mean what it says. It couldn't. But no calm man arose on the Senate floor to suggest that, in truth or in fact, the Negro was both wanted and needed in the South, and that, whether needed or not, he definitely was not wanted in the North.

Yet, and this is the tragic part of it, he will not be wanted in the South either if the region's long history of racial accommodation is turned into the racial hatred that already is beginning to appear. A growing tension is pervading the Southern states. Tempers are getting short. Good will is evaporating into the miasma of intolerance that always follows any violent rupture of social practice and tradition.

We can not see what is at the end of this hideous situation. If it continues, those whose interest in it is more academic than real, more abstract than practical, will surely feel the effects of it, and will realize perhaps too late the consequences of their impracticed tampering with laws and customs whose meaning and purpose they do not understand. And, if we are permitted a prophecy, the greatest victim will be the Negro himself, who will live as an alien in a land cold to his presence and indifferent to his needs.

"All States should follow the lead of the Southern States—for while other States may differ in their feelings on the segregation issue, involved here is the question of whether nine men shall set themselves up as all-powerful, completely irresponsible dictators, with the announced purpose as expressed by the Chief Justice who said that as a Republican office-holder, he believed he would be morally obligated to use whatever means might be necessary to carry out the party platform"—Congressman L. Whitten of Mississippi.

From a member of the State Legislature in Florida: "I depend on the daily papers for news about floods, fire, murder and all types of disaster and crime, but when I want the low-down on the state of the union, I rely on the Southern Conservative. Obscene Books in Illinois School Put Marin County in the Shade

The Southern Conservative is generally credited with being the first paper outside the State of California to publicise the incredibly filthy reference books which were stacked on the shelves of the libraries in the public schools of Marin County, in that State.

Later these disclosures were carried by many publications throughout the country and, with the exception of the officials of the National Education Association, those reading the material were shocked beyond expression. The NEA publicly congratulated Marin County school officials for their refusal to remove the books from their libraries and extolled them for their courage in making this pornographic literature available to young students.

Now, however, we are about ready to pin the white ribbon of purity on the Marin schools and to declare the lewd and indecent books available to children there as mere Sunday School material when compared with those being used in a public school in a small city in Illinois, extracts from which have been furnished us.

Parents there, after getting special permission from Washington to transmit the material through the United States mails to adults only, have furnished us with documented evidence of a course of instruction in sex education for pupils from the 7th to the 12th grades in the public schools there of such foul and depraved nature as to defy belief.

We would not print a line of the material supplied us from some of the school's reference books for all the money in Fort Knox and those who are interested in informing themselves of the extent of organized vice being fostered by school officials in some areas of the nation will have to get their evidence direct. This they may do by writing Mrs. Harold Wilber, President Parents Unlimited, Oreana, Illinois; Mrs. Richard Phillips, Argenta, Illinois; or Mrs. Everett H. Wheeler, Oreana, Illinois, enclosing fifty cents to pay cost of photostats.

Any hope that the National Education Association will conduct any sort of investigation into a situation of this sort is futile. While it undertakes to exercise supervision over the curricula of American public schools, they send their educational Gestapo only into places where pro-Communists are threatened with discharge when their goon squads rush into the area to protect violation of "academic freedom" but the inclusion of obscene reference books for young boys and girls in public schools gets either no attention or NEA approval.

Many Teachers and Preachers Have A Perverted Conception of Their Jobs

The tragic defect in educational instruction being currently given American youth from kindergarten on up through college, is the gross misconception of many educators concerning the responsibilities of their job.

They have boldly set themselves up as possessing some sort of divine authority to mold the economic and political thinking of students and to break down the moral values and social attitudes which these students have acquired from their parents who are the proper custodians in such matters.

In other words, teachers are more and more trying to usurp authority which properly belongs in the home and are making infringements in this field which would once have earned them a good horsewhipping by outraged parents, and they should be dealt with through some similar, if more modern, form of punishment now.

Teachers have one, and only one, function and that is to instruct students entrusted to their care in the subjects to which they are assigned and when they venture outside this field, they should be kicked out without notice.

'The First Point of Attack Is The Brain of American Youth'

It is rumored that powerful Texas oil men, irked by the veto of the bill to free natural gas from Federal controls and the shabby treatment accorded one of their fraternity because of campaign donations, will sit on their hands when check-writing time comes around in the 1956 election.

Any Southerner who claims to be anti-Communist and who, at the same time, can see nothing alarming in the Supreme Court's demand for "integration" can talk until he is blue in the face without convincing us of his genuine concern in stamping out Communism. Mongrelization of the white race is one of the first requisites in setting up a one-world Communist government and the racial violence existing in the South right now is the result of action taken on orders from Moscow and its spokesmen.

CFR is the most powerful under-cover policy-making group in the world and while its membership consists largely of those whose names seldom appear in public print, they represent only top-flight figures who exert final authority in all phases of national and international activity including government, national and international banking, labor, sci-

Why do so many individuals and groups of Americans insist on presenting only half a subject in the discussion of vital matters of great interest to all the people?

The American Association of School Administrators, an offshoot of the National Education Association, for instance, meeting in Atlantic City recently gave out the statement that "If it were left to the pupils, the problem of segregation would soon be resolved. Most of the opposition comes from parents and grandparents."

There was no attempt whatever to explain why this is true, and the impression was left, as it was intended to be left, that there was something radically wrong with the thinking and reasoning of parents and grandparents and that the viewpoint of pupils was sound and unchallengeable.

The truth is, of course, that the reason for acceptance of integration or any other immoral and degrading proposal by modern students is the constant barrage of Communist propaganda which has been hurled at American youth for almost a quarter of a century through the mediums of government agencies, schools and churches and such transmission belts as Americans for Democratic Action and similar groups.

The average American high school and college student is as unfamiliar with the doctrine of Americanism as a Hindoo or a sun-worshipper and if he comes out of a university with anything other than a well-grounded set of totalitarian ideals, it is because of the watchfulness of parents who have been able to off-set the influence of the teaching fraternity.

As Dr. Fred Schwarz, the noted Australian expert on Communism, says, the first point of attack by the Communists is the brain of American youth and, from the results, it is clear that the Soviets have done a bang-up job in this respect, with the assistance of pro-Communists in American educational and religious circles.

ence, religion, education, the press, worldwide communication systems, and industry—with one member in the United States Senate and one on the Supreme Court.

Influence and direct contacts of its membership is worldwide in scope and its tentacles reach out into every country of the globe. There is strong reason to believe that it constitutes the political action arm of the international conspiracy for dismantling the American Republic and its eventual inclusion into a one-world government.

Headquarters of the group are maintained close by the United Nations in New York and its activities are financed by the big tax-exempt Foundations.

Nothing will be done about this all powerful and invisible super-government appendage, of course, but it is well for Americans who never heard of it to, at least, know of its existence.

Betrayed Americans Are Hot Under Collar and Prepare to Fight Back

When the Federal Treasury Department which has granted tax-exemption to numberless organizations of doubtful loyalty, refused a similar grant to For America, on the ground that its objectives were political, leaders of that movement decided to disband as an educational body and re-organize as a political factor in truth and in fact.

Consequently, they are now engaging in a form of political action which, in cooperation with similar groups throughout the country, is offering hope to long-suffering Americans for relief from the internationalist-controlled leadership which has plagued the nation for almost a quarter century.

Headed by sane, able and courageous executives and with strong and locally prominent advisory boards in 33 of the 48 States, For America has gone straight to the heart of the malady now draining the life-blood out of the American Republic by proposing five remedial steps which that group intends to sponsor: Protect the Independence of the United States; Protect the Solvency of the United States; Maintain Peace with Honor; Safeguard the Constitutional Rights of the 48 States and the People; Destroy the Communist Conspiracy and Abolish Socialist Bureaucracy.

To protect the Independence of the United States, For America proposes passage of the Bricker amendment or an effective alternative, keeping out of the Atlantic Union and World Government, terminating the infamous Status of Forces treaty, reverting to policies of George Washington and the Monroe Doctrine, demanding that candidates for President give voters clear-cut choice in foreign policy, that United Nations be reorganized as Association of non-Communist States or that we withdraw from the UN as now constituted.

To Protect the Solvency of the United States, they would protect wage earners by limiting Federal taxes, Federal spending and borrowing, balancing the budget and reducing public debt; they would limit foreign spending, safeguard American markets for American farmers, laborers and manufacturers; make reciprocal trade agreements mutually beneficial, take government out of business and thereby save thirty-seven billion tax dollars per year.

To Maintain Peace with Honor, For America would have us enter no foreign wars unless the safety of the United States was directly threatened, make full use of our industrial potential, create effective, instantly-ready, war deterrent—overwhelming American air supremacy, supported by modern land and sea forces, reject old-fashioned mass Army concept and abolish conscription.

To halt the Federal drive toward Socialism, they would enforce Articles IX and X of the Bill of Rights and leave the complete and exclusive control of public education to the States.

To Destroy the Communist Conspiracy and Abolish Socialist Bureaucracy, For America asks support of Congressional Committees in investigating Communist activities, the upholding of the McCarran-Walter Immigration Act, withdrawal of diplomatic recognition of Communist countries, abolishment of monopoly in business, labor and government, abolishment of the withholding tax, guaranteeing the right to work and the right of those who work to receive their earnings in full.

So there we have it in black and white—a calm appraisal of governmental measures which are rapidly destroying the Republic and sane proposals for their correction and which will permit a return to Constitutional government. Not one item in the diagnosis will be challenged except by internationalists, one-worlders and the "foreigners-first" boys who are falling all over each other's feet in the national capital.

It is because our duly elected representatives in Congress have evaded their sworn duty to the people and have become captives of CIO, ADA, U.N., NAACP and other transmission belts for national and World Socialism that responsible Americans are aligning themselves in increasing numbers with such groups as For America, Federation of Constitutional Government, We, The People, Campaign for the 48 States and other organizations whose membership is becoming tired of constant betrayal by their paid public servants and who propose to try to do something about it.

Sam Rayburn Walks Right Out on A Limb

If there is one thing that politicians dread worse than taking a dose of castor oil, it is being caught on the side of consistency.

No sooner had the Democrats decided to use the state of the President's health as the basis of their campaign attacks than the Honorable Sam Rayburn, "Mr. Fair Dealer" himself, came out and suggested that Lyndon Johnson be groomed as a favorite son of Texas and put up for the office on the Democratic ticket, forgetting that this fair-haired darling of Duval County had also suffered a heart attack sometime ago.

While the performance of a man's heart, liver, kidneys or gizzard would seem to be a rather odd way to evaluate his capacity for leadership, if this is going to be the yardstick by which his qualifications are measured, then it should be uniformly used.

L. A. Republicans Irked at Selection of Case as Speaker

Bona fide Republicans in Los Angeles are up in arms against the Republican Central Committee of Los Angeles County because of speaker who appeared on the Washington's birthday program at Sinai Temple in that city.

They are protesting that Clifford Case of New Jersey, who was the guest of honor on that occasion, hardly is a fitting spokesman for the type of patriotic statesman which they consider the martyred President to have been.

Case's association with the Ford Fund for the Republic, his opposition to McCarthy's investigation into Communism and his support of civil rights legislation, welfare handouts and his general left-wing record was given as the basis of their opposition.

His selection was characterized by local right-wing members of the party as a "kingsize" blunder on that part of those who invited him to make the address.

In Revised Magruder Text Book Author Merely Sweeps Dirt Under Carpet

One of the many Socialist text books which have been used in the public schools has been Magruder's "American Government" which presents forceful arguments in favor of Karl Marx' philosophy and neglects to point out the superior advantages of our own matchless system of free enterprise.

Such a storm of protest has arisen over it by outraged parents and patriotic groups that, ever so often, it is withdrawn from the schools and several half-hearted attempts have been made to revise it since the author's death several years ago.

The latest revision was by one William McClenaghagh and his version is now up for re-instatement in the public schools.

An analysis of this 1956 edition shows that the revision was not a clean-up job but rather a cover-up deal in which the dirt has merely been swept under the carpet.

It is an improvement over the old editions, of course, but it still has a long way to go before it can be regarded as a thoroughly American text book expressing American ideals and capable of properly shaping the economic thinking of American youth.

The propaganda in this volume is more cleverly presented than in the old editions and praise of Socialism is more subtle and subdued. While American institutions are presented to advantage, one-sided information about such international organizations as the United Nations, NATO and UNESCO gives them far greater commendation.

The United Nations as a great medium of world peace is extolled and its buildings in New York are held out as a symbol of hope for people all over the world. All reference to Alger Hiss as the UN architect has been carefully omitted and there is no mention of this agency's failure to achieve the objectives promised by its sponsors.

Perhaps its most fantastic claim concerning the UN is its assertion that this body "settled the Arab-Jewish war in Palestine" which will no doubt be received with surprise by American and British diplomats who didn't know that it was settled and who are at the moment frantically engaged in an effort to stop the violence in that area where Arabs and Jews are firing at each other daily, while the United Nations does nothing. The book also claims that the UN prevented the Soviet Union from seizing the Iran oil fields, another surprising accomplishment since the Soviets are known to be poised and ready to seize this property when the time is right.

The book seeks to achieve an impression of impartiality by giving a few authors in the bibliography, whose Americanism is unchallenged such as Martin Dies, Douglas MacArthur, Jesse Jones, Francis Walter and Arthur Bestor and the Freeman Magazine is also listed. But authors with Communist front records and those of known left-wing views outnumber the others ten to one.

There are listed, for instance, Norman Thomas, Max Lerner, Richard S. Childs, Clark M. Eichelberger, Thomas I. Emerson, John K. Galbraith, Harl Douglas and Charles A. Beard all of whom have one or more Communist front citations. Lerner and Beard later reformed but their books listed in the bibliography were written at the most radical period of their careers.

The bibliography also lists such well-known left-wingers as Gifford Pinchot, Henry S. Commager, Walter Lippman, David Lilienthal, Eric Savareid, Oscar Handlin, Jacob V. Javits, Dean Acheson, Joseph and Stewart Alsop, Arnold Rose and Richard L. Neuberger.

In view of the existing wave of "liberalism" that is sweeping the United States, perhaps this book is the best that we can hope for but the denial of all-American text books to aid American youth in preparing for future citizenship, constitutes a crime against them for which there can be no atonement.

As Americans Peacefully Sleep Their Republic Is Sold Out

Another sinister organization has joined the hundreds now actively working to place the United States in a one-world Socialist government and which, in the meantime, is advocating mongrelization of the White Christian race in this country as a prelude to the eventual dissolution of the American Republic.

The outfit is called World Goodwill and, like all similar groups, it makes its pitch on doing good for humanity.

It describes itself as a "service group" composed of men and women who are members of "one humanity in one world."

They tell us that other "service groups" working with them are often "international in influence" such as UNESCO, Rotary International, World Council of Churches, English Speaking Union, World Brotherhood, benevolent organizations connected with Labor Unions, Fraternal Groups and Student Exchanges" and it is claimed that "members of these groups contribute effort and billions of

dollars annually in the aggregate to achieve a "common objective." Then, it is added in the literature of World Goodwill, "there are a very few unpublicized groups whose members work quietly on world problems."

This group is just one of hundreds doing similar work in behalf of world government and, as claimed, "contributing billions" for the "common objective" and when we think of all this power and influence being exerted against the continuance of this country as a sovereign Republic, we can but shudder at the thought of the future of all the Americans who will have slept peacefully during the gradual transformation of the land of their birth into a one-world slave state.

As in the case of most of the organizations of this character, this World Goodwill outfit is tax-exempt and it boldly announces that funds contributed to it are tax-free — thanks to the Treasury Department of the United States.

There Used to Be A Word for Those Giving Aid to the Enemy South Serves Official Notice Of Intent to Fight Integration

Hon. John J. McClellan of Arkansas was justifiably indignant on February 23rd as he told his colleagues about a secret meeting in Paris during August of 1954, in which our representatives agreed to remove two hundred items from the list previously embargoed to Soviet Russia.

At this Paris meeting, representatives from the American State, Commerce, Defense and Treasury Departments were present and, of course, the ubiquitous Harold Stassen tagged along. As a result of it, our European "allies" can now send the Russians two hundred more items for building up their war potential the better to kill us off.

Senator McClellan charged that the White House had withheld this information from Congress and the people although the truth is that Senator Joe McCarthy found out about it and warned his colleagues soon after it happened but his words went unheeded.

At any rate, there was quite a row stirred up over the matter when Senator McClellan gave the details of the meeting and listed some of the materials which, under this secret agreement, are now being sent by way of our "allies" to the Kremlin, but there were also those who defended this action and thought it was quite all right for us to help the Communists prepare for war against us. Among the items released to them were horizontal boring mills which are essential in the building of armaments such as tanks, artillery weapons, aircraft, heavy ordnance, ships, transmission parts, heavy dies for aircraft, forging presses, catapult parts on aircraft carriers, dynamic balance machines for use in making jet airplanes and guided missiles; also external grinding machines essential in the manufacture of engine parts, guided missiles and radar.

It developed that at the Paris meeting, the American Defense Department pleaded with all the force at the command of its representatives against this direct aid to the Soviet war machine and the building up of Russian fighting forces' equipment to the point where they could level American cities to the ground, but their efforts were in vain.

Indicating how the Defense Department had been whipped into line, Harold Stassen wrote a memo immediately following the meeting which Senator McClellan read to the Senate which said: "I am convinced that this revision which has been made with the concurrence of the Departments of State, Treasury, Defense and Commerce, and approved by the President, will result in a net advantage to the free world of expanded peaceful trade and more effective control of the war potential items. It is a move in the best interests of the United States".

Senator McClellan charged that the White House had repeatedly refused to divulge what happened at the Paris meeting or to make public any list of what new items were released for shipment to our allies for re-shipment to their Kremlin buddies. The Senator from Arkansas finally got hold of the information from a trade publication in England.

To horrified Americans who find it impossible to believe that we secretly made any such commitments as the above we suggest that they read the Congressional Record of February 23, 1956, from page 2771 to and including page 2778.

Five Thousand Fed-Up Americans Indicate There May Be Some Changes Made This Fall

By far the largest, and perhaps the most significant, political gathering since the Presidential campaigns of 1952, took place at Carnegie Hall in New York on Washington's birthday.

It was the occasion of a national meeting called by For America a political action group of the right-wing and for the first time in years, the Hall was jammed to its capacity of five thousand with four thousand turned away.

Speakers included Brigadier General Bonner Fellers, retired Army official who is as straight-talking in the political arena as he was straight-shooting on the battle field; William F. Buckley Jr., prominent young writer-lecturer who not only resisted Red indoctrination by experts during four years at Yale but emerged as one of the nation's top-flight authorities of atheistic Communism on college campuses; Hon. Clarence Manion former Dean of Notre Dame law school who was selected to head the President's Commission on Federal-State Relations because of his reported unassailable integrity and who was fired by Sherman Adams when this report turned out to be true; Senator William E. Jenner of Indiana whose free-wheeling exposure of the myth of "collective security" through such politically motivated outfits as United Nations and NATO has won him the admiration and respect of Americans of both political faiths and the inimitable Senator Joe McCarthy of Wisconsin who is cordially hated by everybody except bona fide American patriots with no record of Communist leaning or Soviet collaboration. Texas' own Dan Smoot was moderator, a function he has performed in many

national forums — always with dignity, efficiency and poise.

The speakers discussed the political facts of life straight from the shoulder and pulled no punches. To the accompaniment of thunderous applause, they expressed the belief that, with the help of America's millions of silent but dissenting conservatives, there will be some changes made this Fall, in policies and in men.

When five thousand busy American citizens from various sections of the country leave their homes and business to travel all the way from one to a thousand miles to hear such outspoken and forthright speakers as the For America program presented, it is a foregone conclusion that they didn't go along for the ride, and public opinion analysts, political columnists and president-makers would do well to give this fact a whirl.

While no gathering of as many as fifty members of a subversive group could take place without blaring headlines from the controlled press, the publicity attending this meeting of good, solid, non-pro-Communist Americans was notable chiefly for its absence outside of New York.

It has been noted, however, that while there was little coverage of this important conclave of seriously disturbed American taxpayers, reams of front page space was available to insults by NAACP Negroes in Washington hurled at Southerners and at a member of the United States Senate and for reporting the capers of a high brown gal in Alabama in her successful attempts to make a shortcut to national notoriety by crashing the doors of an all-white university.

Without flourish or fanfare and with a minimum of advance publicity concerning their intention, one hundred of the most powerful members of both Houses of Congress from the South calmly served notice to the world that the segregation ruling by the Supreme Court which is "a clear abuse of judicial power that has sown hatred and suspicion throughout the South" will be opposed with every lawful means within their power.

Expressing the gravest concern for the explosive and dangerous condition created by this decision and inflamed by outside meddlers, the Southerners pledged themselves to resist forced integration and to bring about a reversal of this ruling which they hold to be contrary to the Constitution. Briefly, the position of these senators and House members is as follows:

1. "We reaffirm our reliance on the Constitution as the fundamental law of the land."
2. "We decry the Supreme Court's encroachments on rights reserved to the states and to the people..."
3. "We commend the motives of those states which have declared the intention to resist forced integration by any lawful means."
4. "We appeal to the states and people who are not directly affected by these decisions to consider the constitutional principles involved against the time when they too, on issues vital to them, may be the victims of judicial encroachment."

All Southern senators signed the document except Kefauver and Gore of Tennessee and Johnson of Texas all three of whom are more concerned, of course, in their own political ambitions than in matters of serious import to the States which they are assumed to represent.

Promoting Communist Cause As Bad as Carrying A Card

The National Council of Churches which was recently the recipient of strong condemnation by a committee of laymen from the churches in its membership because of its political activities, has no intention of taking the committee's suggestions and confining its efforts to purely religious matters.

In a bulletin just issued by that organization, churches composing its membership are ordered to desegregate although the Council cannot fail to be aware that this is a highly controversial political matter and that opposition to desegregation is building up all over the country.

The unfortunate aspect of the political activities of NCC is that all its influence is directed toward carrying out proposals sponsored by the Reds and which are against the unity, safety and security of the United States.

They have denounced all investigations into Communism, have pled for the recognition of Red China in the United Nations, defeat of the Bricker amendment, the emasculation of the McCarran-Walter immigration law and advocate the cancelling out of States Rights through their approval of the illegal ruling of the Supreme Court on segregation.

Ford Foundation Is Soft Touch To Those With Certain Records

A good illustration of how Ford Foundation money is spent is found in the report of the Subcommittee of the Committee on the Judiciary of the United States Senate.

The report of the Subcommittee of which Senator James O. Eastland of Mississippi is chairman was just recently released.

Amos Landman was a witness before the committee at the hearings held last June. Landman, according to his sworn affidavit in Bombay, India, on September 1953, was a Communist Party member which he joined in 1937 or 1938, although he claimed later to have dropped his membership.

During the questioning, he told of his trip to India "to make a study of media of communications such as the press, radio, cinema and the use made of these media by leaders of Indian Society".

To make this study, Landman was given a grant of \$4,500 by the Ford Foundation, he testified, although what possible good could come of such information so far as this country is concerned, was left unexplained.

Landman returned from India in 1954 but when asked by committee counsel if he had made his report on his findings in India to the Ford Foundation, Landman replied: "It is not the policy of

the Ford Foundation to demand reports of persons to whom it gives grants".

If the Ford Foundation boys are not soft touches, it would be hard to think who is. They dole out money to almost any one—provided, it seems, he has or has had, Communist front connections, — and the recipient makes no report and no accounting of the funds. We often wonder what would happen if the heads of the Foundation inadvertently made a donation to some bird who had no Communist front affiliation, past or present. They would probably ask for their money back.

Landman refused, under the fifth amendment, to answer questions as to his Communist connections twenty-nine times during the hearings. It was brought out that he was formerly editorial writer on the now defunct P. M., New York daily newspaper which was liberally loaded with Communists.

This is a typical specimen of humanity which is given tax-exempt money by the Ford Foundation and the record shows that it has been this way since the Foundation was first set up in an effort to escape the payment of taxes and Socialize the United States, thus killing two dirty birds with one stone.

Russian Testifies Two Spy Rings Maintained in the U.S.

The Senate Internal Security Subcommittee which began hearings on the scope of Soviet activity in the United States recently had as its first witness one Yuri Rastorov, former Lieutenant Colonel in the Soviet Secret Police, later Intelligence Officer for the Russian MVD stationed in Tokio.

In 1954, Rastorov quit his job and sought refuge in the United States and he willingly gave much valuable testimony to the Committee covering his eleven years in Soviet Intelligence work.

The most startling information developed by Rastorov's testimony was the statement that Moscow maintains two distinct divisions of its intelligence service in this country, one in the Soviet Embassy in Washington and one in the United Nations, in New York.

Far from causing blaring headlines in the American press, this amazing disclosure received little or no publicity.

It is interesting to compare this tolerance with an imaginary case in which we were found operating a spy ring the the American Embassy in Moscow and to consider what would happen in that event. Still we wonder why the Soviets are able to surpass us in building weapons of war.

Rastorov also told how the Russians were able to fool poor Henry Wallace when he made a trip there in 1944 by routing him on a conducted tour which avoided concentration camps and other things they did not want him to see.

He also told of the fate of Gubichev, Judy Coplon's boy friend, both of whom were caught in the act of passing secret information which Judy had stolen from the Justice Department. Gubichev was allowed to go back to Russia and Judy was freed by Supreme Court decree. Gubichev was fired when he got back to Russia, according to Rastorov, because he fumbled the job and got caught.

On the Honor List: Texas members of Congress who signed the Declaration of intent to protest the Supreme Court ruling on segregation were: Senator Price Daniel, Congressmen Wright Patman, Texarkana; John Dowdy, Athens; Walter Rogers, Pampa; O. C. Fisher, San Angelo and Martin Dies, Lufkin. Constituents of those who didn't sign should demand an explanation in writing. Lyndon Johnson gave out a fence-straddling statement of why his signature was not included.

This, believe it or not, was the statement of Alex Wiley who—officially at least—is a Senator of the United States, from the State of Wisconsin. There are words which would describe how I feel about an United States Senator who says that a President will run for re-election because Europe wants him, but I am not at all sure that those words could, or should be used on the radio".—Frank Kirkpatrick WGN Radio Commentator in broadcast Sunday, January 29, 1956.

As Confucius Says "Those Who Live in Glass Houses Should not Take A Bath"

There is one thing that really smart politicians shy away from in conducting investigations as they would from a hissing rattlesnake and that is the subject of lobbying, realizing, as they do, that there is nothing so lethal or which contributes so heavily to an explosion that blows the roof off as a lobby probe, either State or national. What is more important such investigations have the effect of drying up the source of valuable and necessary campaign contributions.

One of the first lessons learned in the political primer is that practically no politician ever born was elected to high office without financial assistance from those who, in one way or another, come under the classification of "lobbyists."

In view of this fundamental fact of politics it is amazing that even White House advisers were not aware of the potential danger in the President's veto of the Gas bill, accompanied by his pious explanation that he was forced to take this step because of "highly questionable activities" of certain interests whose "arrogant efforts" to "defy acceptable standards of propriety" compelled him regretfully to veto the bill. Why they didn't stop him and, instead, let him walk right into the trap, will probably always remain a mystery.

It all started during the Senate consideration of the Fulbright bill to free natural gas from Federal controls when Senator Francis Case of South Dakota, apropos of nothing at all, came charging onto the Senate floor screaming that Howard Keck, president of Superior Oil Company of California, through his representative, John M. Neff, had tried to seduce him and rob him of his official virtue by offering him a \$2500 bribe to support the Fulbright bill. He added defensively that he had originally intended to support the measure but that because of Keck, by heck, he would vote against it.

One of the few basic rights which have not yet been taken away from the American people through either the Executive, Legislative or Judicial branches of the Federal government is the inherent right of a man to make an ass of himself and the South Dakota senator was obviously determined to invoke this privilege to the fullest.

All this furor immediately set off trigger-happy liberals in the Senate who are always ready to engage in extraneous activities which will divert public attention from their own acts of skulduggery and who decided forthwith that an investigation was in order. White House Republicans and Fair Deal Democrats, after squabbling interminably among themselves as to who was going to investigate who finally settled down with the announced purpose of going to the bottom of this evil practice of corrupting morals through campaign donations.

And so the plan for the inquiry into the nefarious doings of lobbyists and their "arrogant efforts" to defy acceptable standards of propriety by offering "bribes" to public officials was proceeding merrily when right slam bang in the middle of it, up jumped the Devil in the person of Fulton Lewis, Jr.

This universally respected aerial chronicler of the official behavior of the good and the bad alike among those who daily govern us, dropped an A-bomb whose detonation reverberated into all areas of the American Republic except the tightly sealed-off segment known as the American free press.

He announced calmly to his millions of listeners throughout the country that he held in his hand a cancelled check on a Houston, Texas, bank signed by this same Howard Keck which showed payment in the amount of not \$2500, but \$5000, for expenses incurred in the political campaign not of a United States senator but of one Dwight D. Eisenhower in his campaign for the Presidency in 1952.

There are a lot of time-tested maxims which would seem to fit in along about here such as "Let him who is without sin cast the first stone" and "He who laughs last laughs loudest" and others which come readily to mind but these will suffice and, in keeping with the latter, we imagine that Howard Keck, if he has the sense of humor with which all harassed humans should be endowed, is laughing his head off.

Salute From Oregon To the Deep South

Following a visit down in Dixie, Robert F. Bound of far-away Portland, Oregon, was so impressed with the gentle and quiet tempo of life in Natchez that, on his return home, he dedicated a poem to this beautiful city of the old South:

NATCHEZ

In an ante-bellum mansion
By a cypress shaded stream
I spent a velvet hour
Enraptured by a dream

And I heard the gentle laughter
And felt their gracious mood
Then I knew I loved these people
And their way of life was good.

So light the long white tapers
And let the banjos strum
As through the moss-hung trees
The sounds of evening come.

And rose-cheeked Southern Ladies
In crinoline and lace
With beaver-hatted gentlemen
Relive the days of grace.

In Washington, Adam Clayton Powell, Jr., the Harlem Negro who represents his district in Congress asked that the Attorney General list Citizens Councils of the South as subversive. In view of his distaste for subversive organizations, he must not be the Adam Clayton Powell, Jr., former pastor of the Abyssinian Baptist Church in New York, which the Attorney General of the United States in 1948, the Special Committee on Un-American Activities of Congress and the California Committee on Un-American Activities listed as a member of sixteen different organizations cited as subversive and Communist. It must have been some one else with a similar name.

He said a mouthful: "Republicans and Democrats basically believe the same things but run opposition candidates". — Senator Clifford Case of New Jersey who stepped from the Fund for the Republic into the Senate.

Alert American Citizens Render Valuable Service

There seems to be quite an honest difference of opinion concerning the mental health bill now before the Senate, with conflicting claims that it is an honest attempt to extend relief to the mentally ill of Alaska on the one hand and, on the other, the charge that it is an attempt to set up an American Siberia in the far North to which political prisoners of this country may be banished.

At any rate, the widespread interest in the measure on the part of citizens from all sections of the United States is a fortunate and wholesome thing. There is no doubt that there were loopholes in the measure as originally written and there is equally no doubt that these were intentionally placed there by those who are sponsoring it.

But members of the Senate are thoroughly alerted and should be extra careful in cutting out the bugs in it although comrades in the Senate of the original proponents of the bill in the House will try equally hard to get the offensive provisions re-instated in conference.

Altogether, the widespread interest in the matter speaks well for an awakening American citizenship which can exert powerful influence through concerted action.

A member of Congress questioned as to why the measure got through the Lower House with so little opposition replied that this was achieved through a sneak play.

He said that those sponsoring the bill selected a time when there were no important matters on the calendar and most of the members had left.

Under these conditions, it was easy for those favoring the measure to railroad it through with little chance of extended debate by opponents.

The very fact that those favoring the bill took underhanded methods to get it by the House indicates that the suspicions concerning it were well founded and if it hadn't been for the hue and cry against it which arose all over the country, it might have gotten by the Senate in the same manner.

Following the great wave of economy current in government expenditures, the Air Force has announced that a shack is being built to house the Commander of its new Academy at Colorado Springs. It will cost only \$90,000, will contain two living rooms, one formal and one informal, reception room for parties, two dining rooms, dinette, and uncounted number of family bedrooms and guest suites, study, foyer, kitchen, butlers pantry, five and a half baths and servants quarters. By exercising such rigid economy as this, we should soon make an appreciable reduction in the national debt.

In the case of Southern Congressmen who did not sign the pledge of one hundred members of both Houses to fight de-segregation with every lawful means, voters in their areas should demand an explanation. Such Congressmen should be bombarded with letters, telephone calls and telegrams until they put down in black and white why they ignored a matter of such vital import to the South.
