Student Regent, Mitchell Rhodes handed out to the senators his report of the University of Houston Board of Regents meeting held on April 22, 1992. He informed the Senate that Dr. James Pickering has been named Interim President of UH for a term of two years, expiring on August 31, 1994.

He informed the senators that Mr. Daniel Lurvey, the Chairman of SFAC did appear in front of the Board, to speak on SFAC's opposition to President Pickering's proposal to raise Student Service Fees an additional \$2.00 to \$96.00 instead of the \$94.00 recommended by the committee. Mr. Rhodes said that in the end the Board did approve the \$96.00 Student Service Fees. He said that this would mean that the average student taking 15 hours in the Fall would pay \$78.00 more per semester if residents and \$528.00 more per semester if non-residents. Mr. Rhodes encouraged the Senate to work its ways to levy the cost for student attending UH.

Mr. Rhodes said that the Board approved the implementation of a \$15.00 per semester Library Fee and that there were many applause after the Board voted to approve it.
