To all to whom these Presents shall come, know ye

I A. C. Rannels GOVERNOR of the STATE aforesaid, by virtue of the power vested in me by LAW and in accordance with the LAWS of SAID STATE in such case made and provided, do by these presents GRANT to Mexican Emigration and Land Company and their assigns FOREVER, Three Hundred and Twenty Acres of LAND, situated and described as follows: In Shackelford County, on the South Fork of Foye Creek, about 9 1/2 miles South of Bear Fork of Brazos River, and about 3 1/2 miles S. 31 N. of Belknap, known as Survey No. 546, by virtue of Certificate No. 546, issued by the Commissioner of the General Land Office on the 15th day of April 1852.

Beginning at the West Corner of Survey No. 545, a Stake in Mound in Prairie, from which a Mesquite 4 in. dia. b. S. 11 1/4 E. 22 1/2 r. s., another 9 in. dia. b. S. 7 1/2 E. 12 1/2 r. s.

Thence North 45 N. at 103 1/2 r. s. a branch, at 1344 r. s. in all, a Stake in Mound in Prairie, from which a Mesquite 8 in. dia. b. S. 85 1/2 E. 21 1/2 r. s., another 10 in. dia. b. S. 17 N. 14 1/2 r. s.

Thence North 45 E. 1344 r. s. to Stake in Mound in Prairie, from which Round Top Peak b. S. 73 1/2 N. 3 miles distant.

Thence South 45 E. 1344 r. s. to Stake in Mound in Prairie, from which Round Top Peak b. S. 7 1/2 N. about 1/2 mile.

Thence South 45 N. at 47 1/2 r. s. a branch, at 1344 to place of Beginning. Bearings Marked 546 G. L. O.

Hereby relinquishing to the said Mexican Emigration and Land Company and their assigns FOREVER all the right and title in and to said LAND, heretofore held and possessed by the said STATE, and I do hereby issue this Letter Patent for the same.
