In the Town of Gonzalez, this 2^d day of November 1834, came before me at my Office Lewis D. Sowell of this Jurisdiction whom I know to be the party buying receiving & acquiring the two lots in the Town of Gonzalez, known & numbered as one & six in Square Seventeen according to the recognized plan of s^d Town, by a Deed from James Blair Patrick acting Alcalde for & in behalf of the state & Municipality above written to the s^d Sowell bearing date 30th December 1833, and which is recorded & filed in the Municipal Archives of Gonzalez aforesaid, - who acknowledged that for & in consideration of Fifty Dollars to him in hand paid by James H. C. Miller at & before the execution of these presents, - that he the s^d Lewis D. Sowell hath & he doth hereby sell, concede, alienate, relinquish & release to the s^d Miller all the right, title & interest which he the s^d Sowell acquired or received in & by s^d Deed in & to the premises thereby conveyed aforesaid, viz. to the lots No. One & Six in Square No. Seventeen in the Town of Gonzalez before mentioned, releasing quitclaiming & renouncing hereby, both for himself, his sons & successors, to the s^d James H. C. Miller his sons & successors all right or claim thereto, to the end that he the s^d Miller & his posterity may enjoy therein in all & singular the parts thereof a true & proper inheritance forever.

In like manner came James H. C. Miller of this Jurisdiction whom I also know who acknowledged that this instrument & act of sale was just & true, & that he accepts of the same & the

manner & terms thereof:—

Wherefore I James C. Davis
only constitutional Alcalde in & for the Municipality
of Gonzales, have caused the parties to assign this
act, which being executed will be deposited in the ar-
chives under my charge, & a certified copy will issue
to the interested to serve him as a title, which for
verification I sign with two witnesses of my faith
as the law requires, this day of the date.
