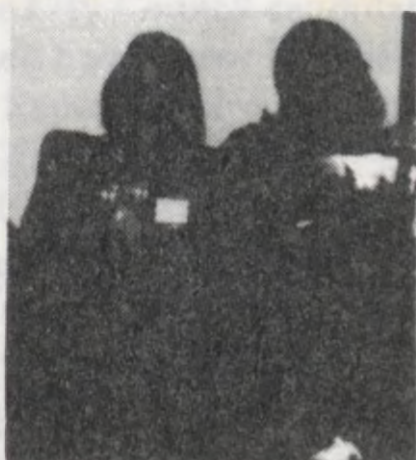

CYR SUIT SAILS ON!

Effort To Repeal Homosexual Conduct Law Fails this Session

END OF ROUND ONE OF LEGISLATIVE BATTLE:

Ft. Worth's Rep. Joe Spurlock, 1 — Gay People, 0
... But Gays Vow, "We will be back!"

(Austin) Rep. Joe Spurlock of Fort Worth has succeeded in keeping Gay People *de facto* criminals in Texas for at least the next two years.

House Bill 759, the original bill which would have repealed Section 21.06 of the Texas Penal Code, never got out of committee as a new Senate-backed bill was introduced which had wide penal code reform including the repeal of Section 21.06.

Section 21.06 is the law which makes it illegal for two consenting adults of the same sex to have sex in private.

In a surprise move to the Texas Gay Task Force, which lead the repeal effort of 21.06, the new bill was debated on the floor of the House. Rep. Spurlock moved to delete the section of the bill which would have repealed 21.06. Rep. Craig Washington (Houston), who sponsored H. B. 759, lead the opposition to Spurlock's motion but was unsuccessful.

The Texas Gay Task Force and the Gay People of Texas lost. One of the TGTF's leaders expressed confidence, however, in the fact that the Legislature was forced to address itself to the Gay issue and is now aware that TGTF will be at the Capitol during every session.

At the House Criminal Jurisprudence

Committee hearings on H.B. 759, the Texas Gay Task Force presented a group of people who supported the bill. Testifying on behalf of the bill were Darrell Blakeway, executive director of the Texas County and District Attorneys Association, who testified that 21.06 was not needed by law enforcement agencies; Rev. Sanford Coon of the Austin University United Methodist Church, who emphasized the support of various church groups; Randy Beitel, co-chairperson of the TGTF legal committee, who testified about various legal ramifications of 21.06 and presented a petition signed by 16 faculty members of the UT Health Science Center in Dallas and a statement by Dr. Robert Dain, president of the Dallas Association of Psychologists, urging passage of H.B. 759; Dr. Janie Eleoseff, a psychologist with the University of Texas, who emphasized the American Psychological Association's support of the bill; Aola Alexander, who submitted a written statement emphasizing the Lesbian/Feminist support of the bill; and Neal Parker, co-chairperson of the TGTF legal committee, who summarized the testimony. There were no speakers who opposed H.B. 759. Rep. Spurlock was not present at these hearings, although he is a member of the committee.

AURA Adopts New Guidelines

(Fort Worth) The membership of AURA, Fort Worth Gay organization, has adopted a new shorter and simplified constitution which was written and submitted by the organization's Constitutional Revision Committee.

The new document kept only Articles I and II from the original 12 articles. Article I names the organization "AURA," and Article II outlines the "Objectives and Purposes of AURA," which were established at its founding, April 6, 1973.

The new constitution then has three articles which deal with membership, meetings and officers.

Major change in the new document is that absolute control of the organization is given to the active members. The active members annually elect two coordinators who then appoint a director. The two coordinators will "conduct meetings, handle business, and handle finances" with approval of the membership. The duties of the director are to "be responsible for public relations" and to "serve as the representative of the membership in all external activities of the organization."

The annual dues system and associate memberships were abolished by the new constitution. To become an active member of AURA, a person need only attend three consecutive meetings and remain active by not missing more than three consecutive meetings. A new classification, Friends of AURA, has replaced the associate memberships. Friends of AURA

are defined as "those persons who shall contribute a minimum of \$5 per year to the organization."

The new constitution specifies that the election of the coordinators take place at the first meeting of May. However, after much discussion, the membership decided that there were too many new members to hold a meaningful election. In order to remain within the constitution the following solution was devised and accepted: Interim coordinators Wayne Ribble and Charles Gillis were elected with the understanding that they would both resign at the July 21 meeting. At that time the membership, better informed and better acquainted with one another, could then elect two persons to fill the unexpired terms.

Ken Cyr is the present director.

GAY SWITCHBOARD PLANNED FOR FORT WORTH

(Fort Worth) Training sessions have begun for a crisis, counseling and information telephone line to serve the Fort Worth Gay Community. The Fort Worth Gay Switchboard hopes to be in operation by the end of May or early June and will be operational seven days a week, 24 hours a day.

The Gay Switchboard is being sponsored by AURA in cooperation with Agape Metropolitan Community Church. Information about the Switchboard may be obtained by calling AURA at 338-0128.

FT. WORTH CITY ELECTION

(Fort Worth) Of the 19 candidates who ran for the nine places on the Fort Worth City Council earlier this year, only four responded to a question posed to them by AURA concerning their opinion of a Gay civil rights ordinance.

Five of the City Council candidates were endorsed by the new "Gay Committee for Fair Representation." A spokesperson for GCFR stated that the sole purpose of the Committee was to endorse political candidates and campaign in Fort Worth for those that they endorse. The spokesperson said that the GCFR is comprised of Gay people who are interested in protecting the rights of Gays and is aligned with no organization but does have support of individual members of AURA and the Agape Metropolitan Community Church.

"Our methods for selecting a candidate that we feel will be beneficial for Gay People will improve with time and rigid standards will be applied in the future," the spokesperson said.

The GCFR passed out leaflets at area Gay bars prior to the election urging Gays to vote for the Committee's slate.

In doing preliminary groundwork for the eventual introduction of a civil rights ordinance for Fort Worth, AURA sent the following question to each of the candidates:

"More than 20 American cities have now passed civil rights ordinances banning discrimination in employment and public accommodations on the basis of sexual orientation. What are your feelings concerning such an ordinance for Fort Worth?"

Here are the results of the election, answers to AURA's question, and the GCFR endorsements:

Place One (Mayor). Cliff Overcash defeated J.C. Pace, Jr., Robert Haas and Gordon J. McKenna.

AURA: None of the four responded to the question.

GCFR: Endorsed Gordon McKenna. The Committee reached its decision after evaluating the "overall philosophy" of the candidates.

Place Two. Joe Bruce Cunningham defeated Robert J. Carpenter.

AURA: Cunningham did not respond;

Motion To Dismiss Denied In Cyr's Police Harassment Suit

(Fort Worth) A Motion to Dismiss the class-action lawsuit filed by Ken Cyr against Fort Worth Police Chief T.S. Walls, Deputy Chief H.F. Hopkins, Capt. C.E. Hogue and two unnamed officers has been denied by Federal Judge Eldon Mahon.

The motion for dismissal was filed by City Attorney S.G. Johndroe, Jr.

The suit, filed February 26 by Cyr, director of AURA (Awareness, Unity and Research Association), centers around a controversy that arose after the recording of license numbers by police at the Texas Gay Conference last June.

In his motion to dismiss, Johndroe argued that Cyr had no "right to bring this suit pursuant to . . . the Federal Rules of Civil procedure."

Johndroe noted that he does not believe gay people or homosexuals are a "class" of people and therefore could not bring a class-action suit.

He said that the police "deny that they have ever subjected plaintiff or any so-called 'gay groups' to any illegal surveillance and harassment." The brief went on to say that Cyr "seeks to insulate himself, his friends and associates, from the enforcement of valid criminal laws . . ."

Johndroe indicated that police admit recording license numbers at the June 22 conference, but said the reason behind the action was that there was fear among police that the conference "might be invaded by outsiders."

In a formal answer to the Johndroe motion, Cyr's attorney, James Barber of Dallas, called the explanation for taking the numbers "a flimsy, merely plausible excuse."

Judge Mahon, in his ruling against the motion, said that "the Court is of the opinion that plaintiff's complaint does allege a cause of action and that dismissal or summary judgement would not be a proper disposition."

DALLAS CITY ELECTION

(Dallas) Recent city elections in Dallas saw Gays confronting the mayoral candidates for the first time.

Representatives Scott Stebelman and Michael Merrill of the Gay Organization of Dallas appeared on WFAA's public affairs program, "At Issue," which hosted the candidates for mayor. In a question period in which the candidates took questions from the audience, G.O.O.D. representatives asked the candidates if they would support city legislation banning discrimination against Gay People in city employment.

Mayor Wes Wise, claiming that he had never heard of anti-Gay discrimination, said that he would support an ordinance protecting Gays if G.O.O.D. could produce evidence that discrimination against Gays exists.

CCA candidate John Schoellkopf said that he had no position on the question. Candidates Emory and Steakley took the position that all people should have equal opportunity in employment, although Steakley erroneously believed that Gays were protected under the Civil Rights Act of 1964.

SPEAKERS

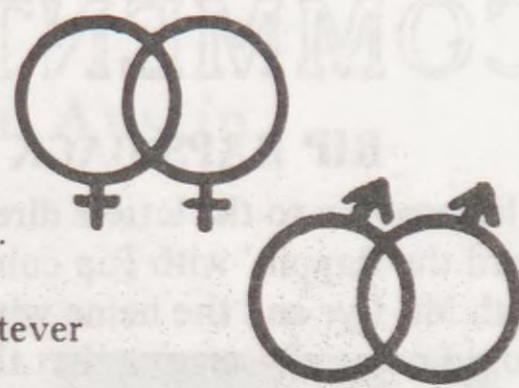
To date, we have two definite speakers highlighting the Conference:

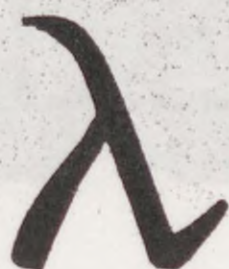

Over 60 members of the Gay Academic Union and other interested persons met Saturday, April 12, for the first regional conference of the South Central Region. The day-long workshop was hosted by Gay People of Austin and Austin Lesbian Organization. Art Addington served as coordinator for the event.

The day's activities provided a first opportunity for gay persons to meet others who are also involved in some way with the academic world — as administrators, teachers, librarians, and students — or the professional world — doctors, lawyers, nurses, etc. Discussion groups explored social, legal, and employment problems affecting gay educators, professionals, and students. Several participants related their personal experiences, both positive and negative, in coming out with straight colleagues and in their institutions.

Two papers were also presented. One, entitled "Psychological Investigations in Androgyny in Males and Females," was given by Robert Helmreich and Steven Ward of UT Austin. This paper, quoting a large scale research project, notes that persons possessing both "feminine" and "masculine" traits are happier and rate higher in self-esteem than people having only one trait. B. Jaye Miller, of the University of Houston at Clear Lake City, presented "Homosexuality and Decadence in Western Literature," in which he recommended a redefinition of "decadence"; he illustrated that so called periods of decadence can be "exceptionally ripe, not just in terms of artistic experimentation and creativity, . . . but also in terms of great political, moral, psychological, and religious growth."

After meeting in separate caucuses, the men and women pooled their suggestions for the formation of a steering committee and submitted their resolutions. It was decided by the conference participants to form a steering committee of 6 women and 5 men with the goals of increasing membership in GAU, publicizing our existence, mailing a newsletter, and planning the next conference to be held within a year. There was also some interest in the publication of an academic journal of Gay men and Lesbian studies, and the committee plans to investigate such an undertaking.


BAILEY STREET WHEREHOUSE OPENS IN FT. WORTH


The 6,000-foot showcase features the Red Room, a piano bar, the outdoor Beer Garden and a restaurant featuring delicious sandwiches.

LOCAL CHURCH BACKS GAY METHODIST MINISTER

(San Antonio) The congregation of St. Stephen's United Methodist Church in San Antonio, Texas, has voted to support former Methodist minister Gene Leggett in his attempt to have his ministerial credentials restored.

It was in 1971 that the Southwest Texas Annual Conference of The United Methodist Church suspended Leggett's ministerial orders upon his public announcement that he was a homosexual and involved in a ministry to gay people through his Dallas based organization, House of the Covenant. Since that time, Leggett has made an annual appeal to the conference's Board of the Ministry for reinstatement. Each time his appeal has been rejected. At this year's meeting in Dallas, the Board claimed that there was a lack of sufficient new data to warrant a change in the 1971 action suspending Leggett.

In 1973 the Judicial Council of The United Methodist Church ruled that there was another avenue by which Leggett might seek restoration of his credentials. If a local congregation would attest to his character and recommend restoration, the question would have to be voted upon by the entire ministerial delegation at their annual conference. The action taken by the St. Stephen's congregation on April 13 makes this avenue a reality for Leggett.

"This will be the first time since 1971 that the entire conference delegation has had to deal with my request for restoration," Leggett reported. "The action taken by St. Stephen's congregation is very significant for the life of our church. A local Methodist church has placed the qualifications for ministry on a basis other than sexual orientation. St. Stephen's knows that I am gay. However, they are not interested in labels of hetero or homo."

Since becoming a member of St. Stephen's, Leggett has taught both youth and adult Sunday School classes, served on committees and assisted in worship services. He has been hired by the congregation as church janitor.

Leggett enjoys his role as janitor at St. Stephen's. He reports satisfaction in "keeping clean the House of the Lord." He is also quick to point out that the Church must come to terms with its unstated policy that a gay person is fit to clean out toilet bowls but not fit to proclaim the Word of God. "At our 1972 quadrennial General Conference in Atlanta, our church affirmed the civil and human rights of homosexuals. Now the Church has the responsibility to spell out these rights. Do our rights go beyond sweeping and mopping?"

The action of the St. Stephen's congregation does not deal with the issue of the appointability of a gay minister to a local congregation. The restoration of Leggett's credentials would give him the right to call himself a minister and allow him the right to perform such ministerial functions as the celebration of holy communion, baptism and marriage within the boundaries of the St. Stephen's Church.

It would not restore his membership in the Southwest Texas Conference or give him the right to an appointment by that conference.

The outcome of Leggett's action, however, will play a significant role in the upcoming 1976 United Methodist Conference in Portland, Oregon, where the ordination of homosexuals is expected to be a major issue.

"Regardless of the action taken concerning my ministerial orders," Leggett concluded, "I shall continue to work with other gay Methodists in sensitizing the Church to the oppression of gay people by the Church and society at large and the need for an open ministry for all our Methodists concerning homosexuality."

Carpenter stated in full: "I have not been subject to a discussion concerning this subject. So I do not know on what basis you and your associates base your concept of sexual orientation. As of now based on Christian principles and biblical knowledge, I would be opposed to any ordinance which would legalize the joining together of any persons other than a man and woman."

GCFR: Did not endorse any candidate.

Place Three. Jim Bradshaw defeated Jack Williams in a runoff after elimination of Richard Hyde in the initial voting.

AURA: Hyde and Bradshaw did not respond. Jack Williams sent the following statement to AURA: "I believe Fort Worth should comply with all anti-discrimination decisions of the Supreme

Court. I believe Gay People are entitled to all the rights given all other citizens — no more and no less."

GCFR: Endorsed Jack Williams

Place Four: John J. O'Neill was unopposed. He did not respond and there was no endorsement.

Place Five: Hugh Parmer ran unopposed.

AURA: Parmer did not respond.

GCFR: Endorsed Parmer (The Committee did not explain why they endorsed Parmer.)

Place Six: Woodie Woods defeated the incumbent, Leonard Briscoe.

AURA: Briscoe did not respond.

Woods sent the following statement: "It is not my nature to discriminate against any human being for any reason. As a public servant, I would be even more aware of this trait. If discrimination existed and could only be controlled by ordinance, then I would support such an ordinance. Thank you for your concern."

GCFR: Endorsed Woodie Woods.

Place Seven: Richard Newkirk defeated Bill Turner in a run-off after elimination of Joe R. Keeton in the initial voting. No response and no endorsement.

Place Eight: Henry A. Meadows ran unopposed. He did not respond and there was no endorsement.

Place Nine: Margaret Rimmer defeated Bill Smith.

AURA: Rimmer did not respond. Bill Smith's reply started with "... some of the best friends I have in this world are Gay People ..." and ended with "but you and your people have my word on one thing: I will never introduce an ordinance such as you have mentioned."

Commenting on Smith's reply, AURA

Director Ken Cyr said, "It seems like he was trying to imply that Gay People are interfering with straight peoples' rights by our fight to be protected against discrimination."

GCFR: Endorsed Smith with reservations. The Committee explained that, as in most of the other places, it was a choice of the lesser of two evils.

SEX REFORM PASSES IN CALIFORNIA

(Sacramento, CA) California lawmakers have approved a bill to repeal the state's harsh laws against oral copulation, sodomy and adultery which previously carried penalties of up to 15 years in prison for oral copulation and life in prison for (rectal) sodomy.

The bill, introduced by Assemblyman Willie Brown, passed the Assembly on a 45-26 vote and then squeaked through a more conservative Senate on a tie-breaker vote cast by the state's Lt. governor.

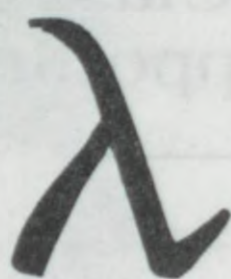
The measure, which has been signed into law by Governor Ed Brown, will be effective January 1, 1975. The governor had previously expressed privately to Gay leaders his willingness to sign such a bill.

COUNCIL OF CHURCHES ENDORSES GAY RIGHTS

(Chicago) The Governing Board of the National Council of Churches has endorsed equal rights for Gay People. The Board, representing 30 Protestant and Orthodox denominations, passed a resolution March 6 calling for legislation to ensure "full civil rights" for anyone facing bias "because of their affectional or sexual preference."

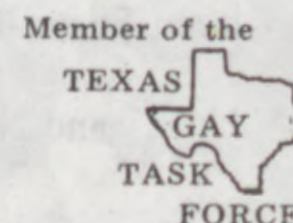
The action followed a year and a half of effort by the National Gay Task Force on Gay People in the Church.
