 thousand two hundred and thirty four
 dollars to me in hand paid, to my satisfac-
 tion do by this act sell release and quit
 claim to the citizen James Whiteside all of
 my right title and interest in and to the follow-
 ing named and described tract of land
 as granted to me by the Government of Colo-
 ra and Texas. Situated lying & being,
 in the County of Hay M. on Buckner's
 Creek part of the League of Land No 10.
 of the North west part of the 3d League
 containing Twenty Six hundred and seven-
 teen acres being the whole League save one
 quarter Eleven hundred & Eleven acres
 sold to Simms, and three hundred sold
 to Buster and four hundred sold to
 W. W. Gant - all amounting to Eighteen hun-
 dred and Eleven acres - and by these
 presents do warrant & for ever defend
 the said tract or parcel of land
 containing Twenty Six hundred and
 seven acres to the said James Whi-
 teside and his heirs for ever in testimony
 any whereof I here unto set my
 hand and seal. This 9th day of
