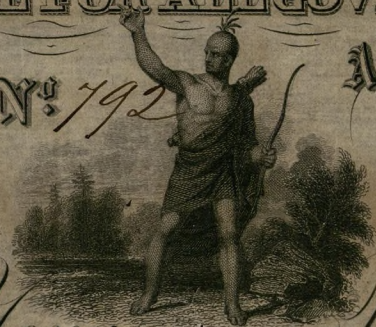

with interest at the rate of Eight per cent per annum from date hereof payable semiannually on the 1st days of January and July at the Treasury Department in Gold or Silver on presentation of this Certificate and delivery of the proper Coupons hereunto annexed the first payment of interest to be made on the first day of July 1st 1841. The principal redeemable at the pleasure of the Government after the first day of January 1846. This Certificate including the installments of interest which may have been made shall at all times be receivable in Collection of the Revenue and in payment of any dues to the Government.
