## States Have Constitutional Power To Abolish Congress

Washington politicians try to mitigate their transgressions of States Rights by pointing up their efforts in behalf of "Human Rights."

They employ this dodge to avoid facing up to the accusation which is justifiably made that the Tenth Article of the Constitution, which reserves to the States all rights not specifically granted to the Federal government, has been practically nullified by the heretics now in control of the Demo-

This is especially true in the case of a big blowhard in the United States Senate who breezed into that office on a blast of hot air generated at the Philadelphia Democratic Convention where he helped the slap-happy delegates to defeat a resolution defending States Rights.

In this way a political pipsqueak, whose only claim to distinction is that he was successful in preventing a party endorsement of the basic and fundamental principle on which that party and our government itself were founded, has been able to influence increasing Congressional disregard of the superior and outranking authority of the States over that of the Federal government, their agent.

The average citizen's lack of familiarity with the provisions of the Constitution in setting up the framework of our governmental system is appalling but not nearly so devastating as the ignorance of, and disrespect for, those provisions on the part of those elected to make our laws and sworn to defend and uphold our organic principles.

Instead of there being no such thing as States Rights as claimed by these insufferable demagogues, there is no such thing as Federal Rights except in the case of those which have been conferred on the Federal government by the States, under the precise and exact terms of the Constitution which they created.

Centralization of power in a Federal agency was the one thing above all others which the founders of our government sought to avoid in laying its framework and designating the method under which it should operate in the interest of all the people.

To this end the Federal government was set up merely as a Union of the States enjoying only such power as was delegated to it by the States such as the sole power to make treaties with foreign governments, to make war, to raise and support armies and navies, to lay and collect taxes, duties imposts and excises, to borrow and coin money, to fix standards of weights and measures, to establish post offices and post roads, to grant patents and copyrights, to establish courts to regulate commerce between the States and foreign nations and to do certain other things consistent with its proper functioning.

There was never at any time, nor was it ever intended that there should be, a surrender of sovereignty by the States to the Federal government and it has only been by usurpation of such authority in recent years that the Federal government has embarked on projects and engaged in activities which are strictly unauthorized and unconstitutional.

Congress cannot be blamed exclusively for this, however, and much of the responsibility must rest with the State Legislatures, for the ignorance of State Legislators concerning their own power is as profound as the arrogance of members of Congress who have attempted to wrest this power from them from them.

This usurpation of power and authority by the Federal government has given rise to the fallacious theory, abjectly accepted by an uninformed and indifferent citizenship, that the Federal government is supreme and that the States are some sort of "dominions" over which Washington exercises

## **Back To The Pulpit With Political Preachers**

A charge which has repeatedly been made by responsible persons and agencies to the effect that subversive forces dominate an organization known as the Federal Council of Churches of Christ in this countryan astounding accusation which has been difficult for most of us to believe -has had substantial confirmation.

Meeting in Detroit in February, this body spent four days in serious consideration of practically every question in the whole category of topical subjects, except religion.

Taking up the matter of governments first, this amazing segment of a profession commonly supposed to be dedicated solely to the salvation of men's souls, took our own Capitalistic System and dumped it into the pot along with Communism and Socialism and denounced them all.

That their real purpose—or rather the purpose of those forces who are directing their activities-is to discredit the governing system of our own country and that their repudiation of Communism and Socialism was merely lip service, was forcefully proved in the resolutions resulting from their "deliberations."

These included a plea for the redistribution of the wealth of this country by means of taxation, although why they felt that any further steps along this line short of total confisca tion of property could be taken which would exceed the tax levies currently in effect, is difficult to understand.

They also lent their support to a program of Socialized Medicine, Federal Aid to schools and equality of

In fact, so far as we can learn from press reports, their recommendations duplicate in every essential detail the platform of Henry Agard Wallace in his campaign for president of the United States in 1948.

The naivete of preachers when they leave the pulpit and mount the political rostrum and their susceptibility to the wiles of designing politicians who seek to enlist their services in a particular cause, is generally understood.

## Relief Dole Continues to Mount Under "Truman Prosperity"

The joint Federal-State relief agencies which Roosevelt promised would What The Country Needs be discontinued as soon as the "emergency" in 1933 was over will supply cash assistance during the coming year to 4,500,000 needy persons, according to estimates submitted recently to Congress by the Bureau of Public Assistance.

This is reported to be a million more persons than will be drawing social security checks.

It is also forty per cent above the number who were aided ten years ago through the same programs—old age assistance, aid to the blind and aid to dependent children.

Total cost of the program is estimated at \$2.3 billion dollars.

#### Another Economic American Tragedy Costs Taxpayers \$37,000,000

The notorious case of the Lustron Corporation, financed by the Federal government and whose very peculiar methods of operation were exposed by a noted commentator over the air sometime ago, has come to an end.

As in all attempts of the Federal government to engage in private business, the venture ended in a dismal flop with the taxpayers, as usual, having to take the loss.

The concern which proposed to make pastel-tinted prefabricated lustron houses, and which project was said to have the whole-hearted support of White House economists, was subsidized to the extent of \$37,000,000.00 with little chance of the government recovering more than a few gents on the dollar. cents on the dollar.

The payments to the company be-an in June of 1947 and have been ept up from time to time in spite of the failure of the concern to live up to its contract.

This amendment would provide for election of a President by popular vote, instead of by the Electoral Col-

Those who have studied the amendment carefully point out that it would correct deficiencies in the present system of electing a President and that if it had been in effect in 1049. Trumpan would not have been 1948, Truman would not have been elected, as he failed to get a majority of the popular vote.

## Supreme Court of Texas Is Not "Packed" But Acts Like It

In the practices of politics corruption is always more contagious than integrity and this unfortunate fact has been given substantial confirmation once again.

Heretofore the comparatively recent custom of high courts handing down political decisions instead of judicial rulings has largely been limited to the Washington area but the contagion seems to be spreading.

The latest tribunal to have its judges seemingly base their findings political expediency, rather than statutory enactment, is the Supreme Court of Texas.

The decision involves proceedings at the so-called Democratic State Convention held at Fort Worth in Sep-

At this Convention, Neville G. Penrose and Mrs. Bennett L. Smith of Fort Worth who had been duly elected as committeeman and committee-woman from Tarrant County at the previous County Convention, in compliance with provisions of the Terrell Election Law governing the selection of Party delegates, were thrown out and replaced by a couple of Left-Wingers, Jack Carter and Mrs J. W. Douglas of Fort Worth.

In a suit brought before a Fort Worth District Court, styled Homer Tomlinson et al vs. Jack Carter et al, a verdict was rendered in favor of Penrose and Mrs. Smith. A similar decision was handed down by the Court of Appeals at Fort Worth in a later trial of the case.

On appeal to the Supreme Court of On appeal to the Supreme Court of Texas, however, the verdict was one reminiscent of some of those of the Supreme Court of the United States at the height of New Deal tyranny when Judges put their ears to the ground instead of their eyes on the Constitution, in arriving at a decision.

In the face of the law which clearly defines the manner in which delegates to the State Convention are to be elected and in spite of all evidence that Penrose and Mrs. Smith had been elected under the procedure set up in this law, the opinion of the Supreme Court, written by Chief Justice John H. Sharp and concurred in by seven Associate Justices, held that the regularly elected delegates were ineligible to serve and that the two Truman radicals selected by the State Convention were entitled to such offices.

An amazing sidelight on the hearing before the Supreme Court at Austin was the action of Robert W. Calvert, who was Chairman of the so-called Democratic State Executive Committee of Texas in 1948 and who was one of the first Party officials in the State to abjectly obey instructions when ordered by stronger-minded leaders to fall in line.

Calvert broke all precedents of counsel in cases before that body who invariably display respect and reverence for the dignity of its members, by boldly reminding them that if the Democratic State Convention held at Fort Worth in September of 1948 was not in fact duly constituted and convened, and its actions upheld, some of the very Judges sitting on the Court were not legally entitled to do so because their election in the Description.

Of all the nine Judges, Associate Justice Smedley alone refused to be swayed and handed down a minority ruling in which he quoted the law as written and on which he based his opinion.

It is not expected that an appeal to the Supreme Court of the United States will be made as such a procedure would be a futile gesture in view of the fact that any ruling affecting the fortunes of the political Party which appointed its members, is always known in advance of its official decisions

The Republic and its institutions The Republic and its institutions have suffered irreparable damage as a result of the official and quasi-official acts of these two bungling meddlers but at least further misconceptions of presidential authority may be prevented by backing up, starting all over again and re-establishing clearly the relation of a public official to the people who elected him.

A step toward this is for Mr. Truman to be put right and his mind disabused of the idea that he is a supreme and deified ruler answerable to no authority but his own sweet will.

## Truman Sees Allowable **Exemption As "Tax Loophole"**

Taxpayers need no example of Mr. Truman's contempt for legitimate business enterprises or his lack of sympathy with the problems of private

His efforts to have the provision of the internal revenue measure which permits oil producers a  $27\frac{1}{2}$  per cent depletion allowance, provide an excellent example of both.

It not only encourages the invest-ment of private capital in oil ventures, but is an aid to our National Security by insuring that an adequate supply of domestic oil will be available in case of emergency, when foreign oil importation might be cut.

In asking Congress to remove this small depletion allowance the President contemptuously referred to the provision as "one of the tax loopholes which should be plugged."

By inference, those great pioneers in the world's most elusive, precarious and unpredictable industry are classed as law violators who are using a "loophole" to cheat the government of its just dues, even though the 27½ per cent depletion allowable is part of the law of the land.

Legitimate business men have been Legitimate business men have been viewed as common criminals for so long by Washington administrations that the public no longer takes notice of unwarranted attacks on them, but the President's implied criticism of them for complying with the statutes as written, is a new line of attack.

There are some holes in Washington that need to be "plugged" all right, but they are not tax loopholes. They are rat holes down which Truman has poured more than one hundred and ninety billion dollars of taxpayers' money while on his reckless souandering jag.

coming to our shores from foreign countries who have no understanding or sympathy with our form of government and who believe that all authority stems from a centralized agency.

It is this alien school of thought which has grafted on our system all sorts of damnable foreign ideologies with which we are now burdened.

Statesmen who drafted the Constitution had watched the operation of the decadent, rotten and mouldering governments of Europe and patriotically and successfully sought to avoid the weakness, impotence and corruption of those systems in building our own organic structure and to avoid the very pitfalls into which we have now fallen.

While Federal usurpation of power rightfully belonging to the States was begun in mild form during the administration of Woodrow Wilson, we have Franklin D. Roosevelt to thank for making the transfer of authority from the States to the Federal government almost complete.

He did this at the same time he was attempting to change the name of the United States from that of a Constitutional Republic to that of a "Democracy" and while he was also reversing the revered American doctrine that elected officials are the servants, and not the masters, of the people.

That he got away with it until the day he died is tragic testimony to the weakened moral fibre and degeneracy of the American electorate which sank to the lowest depths of servility and groveling acquiescence under the New Deal and which seems unable to lift itself to a higher level.

There is no better time than the present for little political whippersnappers in Washington who boast of the vast power of the Federal government to be reminded that it is completely within the authority of the States, under a strict interpretation of the fundamental principles upon which our system of government was founded and functions through its framework, the Constitution, to do away with Congress and the Federal government altogether, if they were of a mind to take this step.

The States made the Constitution and appointed the Federal government their agent. Obviously principals may alter, amend or abolish their creature

Under one of the ways provided for amending the Constitution, onethird or thirty-two of the State legislatures may pass a resolution memorial-izing Congress to submit such and such an amendment back to the States for ratification. Congress must then submit this amendment and when threefourths, or thirty-six, States have ratified it, the amendment then becomes part of the Constitution.

Let us say that thirty-two States memorialize Congress to submit an amendment back to the States providing for the abolishment of Congress and the Federal government. Under the Constitution, it becomes mandatory on Congress to submit such a resolution to the States. If three-fourths of the States ratified the amendment, it would automatically become part of the Constitution.

Of course the illustration is strictly academic as no such action will ever Of course the illustration is strictly academic as no such action will ever be taken but it serves to point up the superior authority enjoyed by the States over that of the Federal government and the cheap imitators of Alexander Hamilton in Washington who are constantly seeking more centralized power need to be reminded of it every time they pop off about the prestige of the Federal government.

When a sufficient number of our citizens are alerted to the danger of the continued abrogation of the Rights of the States by the Federal government and realize that this is the last step in the destruction of our Constitutional Republic, as a prelude to a Socialist State, we may be able to get enough concerted action to return the Federal government to its proper status as a creature of the States with power to act only within its Constitutional authority. tutional authority.

And since this is still a government of forty-eight groups of people, the citizens themselves are the ones on whom the responsibility must rest of reasserting, re-establishing and preserving the immortal principle of the Rights of the States.

Fortunately, we are one of the few remaining nations of which this can be said.

In Russia and other countries behind the Iron Curtain, the people have absolutely no recourse against this, or any other form of tyranny.

They are stuck with their rulers until death—or a bomb or bullet ends their term of office.

In this country, on the other hand, the people themselves are the Court of Last Resort and, under our form of government, every voter is a Sovereign and every citizen a King.

If this supreme authority and final responsibility of the people to compel their elected servants to respect and obey established laws underlying our governing system, are recognized, accepted and reflected at the ballotbox, there is still hope of restoring our Constitutional Republic to the full vigor enjoyed and exercised by it upon its creation by the States.

It holds \$200 millions worth of flaxseed and linseed oil; \$151 millions worth of tobacco; \$89 millions worth of dried eggs; \$60 millions worth of butter; \$53 millions worth of wool, and \$42 millions worth of dried beans; also \$27 millions worth of dried milk and \$240 millions of other commodities, including peanuts and soybeans.

The President devoted practically all of his speech at the "Jackson Day Dinner" in Washington to a denial that the erstwhile Democratic Party is now shot through with Socialism.

In addition, constant repudiation of the established principles of States Rights and attempts to force degrading social practices on the South through so-called Civil Rights Legislation constitute planned and deliberate acts of rudeness, intimidation and political browbeating which no decent and self-respecting Southerner will take lying down.

In fact, there is nothing in the way of double crosses, insults and fast curves to be thrown at the South which have not already been offered and there is nothing to be lost by fighting back with claw and fang and with no holds barred.

It may be that our efforts will avail nothing and may prove as ineffectual as a dog baying at the moon, but, although it may possibly be claimed in future that we failed to accomplish anything in stemming the Radical tide that threatens us, it will never be said that we didn't try.
