

NACHO-BUCHANAN LAWYER TOGETHER

Dallas, Tex. - Buchanan case attorney McCluskey, withdrew his consent to the intervention of the North American Conference of Homophile Organizations in the appeal now before the U. S. Supreme Court early in October. After reconsidering he said he would give consent for their petition.

"I have reconsidered, and I feel that any personal animosity that I have has to be put away for the purposes of this lawsuit, and I have consented to the reinstatement of the amicus brief being prepared by Prof. (Walter E.) Barnett," McCluskey said October 7.

Barnett is serving as counsel to the National Committee for Homosexual Law Reform, the successor to the NACHO legal committee which instituted the amicus action in the case on behalf of NACHO.

He was notified by McCluskey on Sept. 17 that McCluskey was withdrawing his consent for the NACHO brief as he had said he would do if NACHO failed to censure or remove committee chairman Austen Wade by Aug. 30, or Wade apologize for his actions in connection with a dispute over funds contributed for the appeal. NACHO took no action and the committee subsequently withdrew from NACHO to reform as the NCHLR.

Both Barnett and Wade said the withdrawal of McCluskey's consent would have no effect on the status of the NACHO brief.

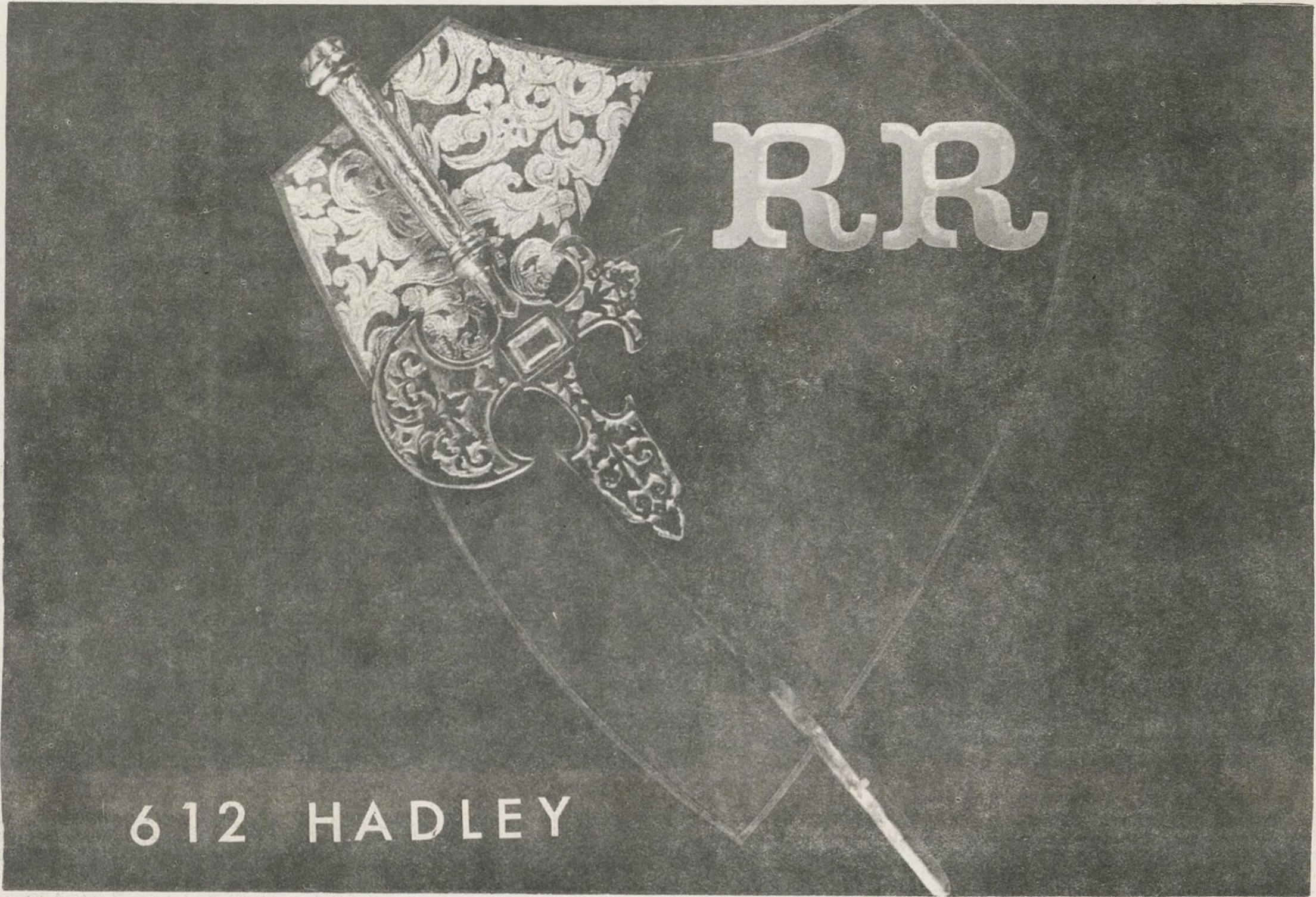
RAY HILL SENTENCED

Raymond Wayne Hill, 29, an ex-convict, drew 20 eight-year prison terms Thursday for burglary and felony theft.

Ray Hill as he was known to many of us was active in a number of the bars and clubs in the Houston area. He was manager for a time of the Plantation Club when it was still in operation before the fire on West Gray. He opened and ran for a short time a private club on Lovett Blvd. He was spokesman for the homosexuals

on a local TV program and interested in an organization which included prominents in our circle which is now forgotten.

Hill, of 729 Manor, pleaded guilty before District Judge Edmund B. Duggan to 10 charges each of burglary and theft. Prosecutor Warren E. White recommended the sentences, which will be served simultaneously.

Hill, at the time of his arrest, was the manager for Mrs. Judith Ann Wolfe, 31, who filed in the Democratic primary for the Seventh Congressional District. She dropped out of the race after paying \$50 of a \$4,250 filing fee.

Hill was sentenced to three years in prison in 1964 for passing a forged instrument.

Mrs. Wolfe is scheduled for trial Jan. 4 on charges of burglary and theft.

She and Hill were indicted after they were found hiding beneath a stairway at the Austin Company, 2727 Buffalo Speedway on February 26.

Hill has been in jail since his arrest. They were discovered when Houston police answered a burglar alarm.

McCluskey, howdver, said that "according to the rules of practice of the U. S. Supreme Court, to file the amicus curiae brief, you have to get the consent of one or both of the parties to the lawsuit and/or, you have to apply to the Supreme Court and have the court grant permission itself."

McCluskey said he had turned information over to postal authorities in connection with the funds dispute.

The Supreme Court convened Oct. 5, but gave no immediate indication whether it would hear the Buchanan appeal. McCluskey filed a motion in June asking the high court to dismiss the appeal by the State of Texas in the case on the ground that the state had filed its brief two days late.

There are actually two main appeals in the case. One, the state's, challenges the ruling by a three-judge federal court in Dallas last January that the state's sodomy law was unconstitutional because it violated the rights of a married couple, Mr. and Mrs. Michael Gibson, who had intervened in the case with Alvin Buchanan, a 32-year-old admitted homosexual challenging his conviction for alleged sex acts in a Sears, Roebuck and Co. restroom.

The second appeal was filed by McCluskey on behalf of Buchanan and Travis Strickland, another admitted homosexual intervening on the ground that the law threatened him because he had sexual relations with another man, although he has never been charged.

The purpose of the second - or cross-appeal - was to reinforce and broaden the original ruling to specifically cover the rights of homosexuals to have sexual relations with each other.

Without the state's appeal, the cross-appeal would have almost no chance of being heard by the high court.

Buchanan's case also comes up in the state Court of Criminal Appeals in the near future.

Relations between McCluskey and Buchanan have reportedly become strained as a result of the funds dispute and the actions of the NACHO committee and its successor.

Buchanan was hospitalized as a result of an on-the-job injury September 11, and had been expected to undergo an operation for a possible slipped disc in his spine.

The operation has been delayed, reportedly as a result of legal complications involving insurance and liability coverage, and he has been released from the hospital and has been getting around on crutches.

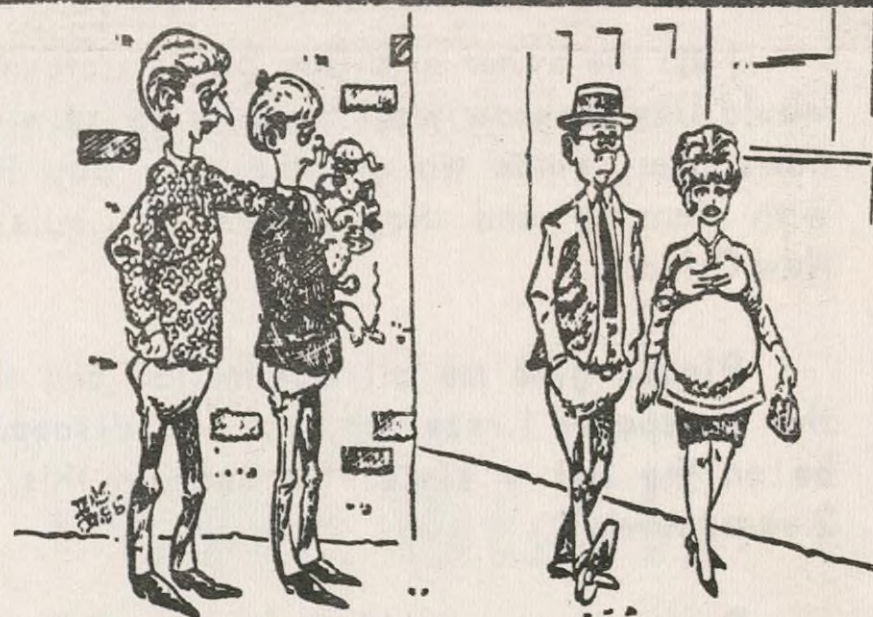
The landlord has been spending much time out of town the past two weeks -- we think he is gone on business -- or something! One occupant of upstairs flew off with the last hurricane.

Mr. Lavine said, "the two minors were not served anything but "coke" and their cards were stamped, "NO ALCOHOL". At this time the defense or outcome of this action is not known.

The Palace Club was not closed at the time. Rumours of a raid and the club having been closed were both false.

The Red Room at 912 Hadley was checked by fifteen, (15), uniformed Houston Police this past week. There were no violations or arrests. (1 arrest outside the bar).

It is reported by customers in the bar that they were not permitted to leave for some time. Snide remarks and smart cracks were made by the officers to a number of club patrons. This action and voice is uncalled for by personnel of our law enforcement representatives! Are standards lower here in Houston for uniform officers than in other cities?

The Gold Room was also checked the same date as the Red Room. Nineteen other bars were checked the same night, seventeen being "straight" so it is not evidenced that "Gay Bars" are being singled out.

It is the law — "Anyone, regardless of age, must have acceptable identification on their person". This will save embarrassment for you as well as the club operators if complied with.

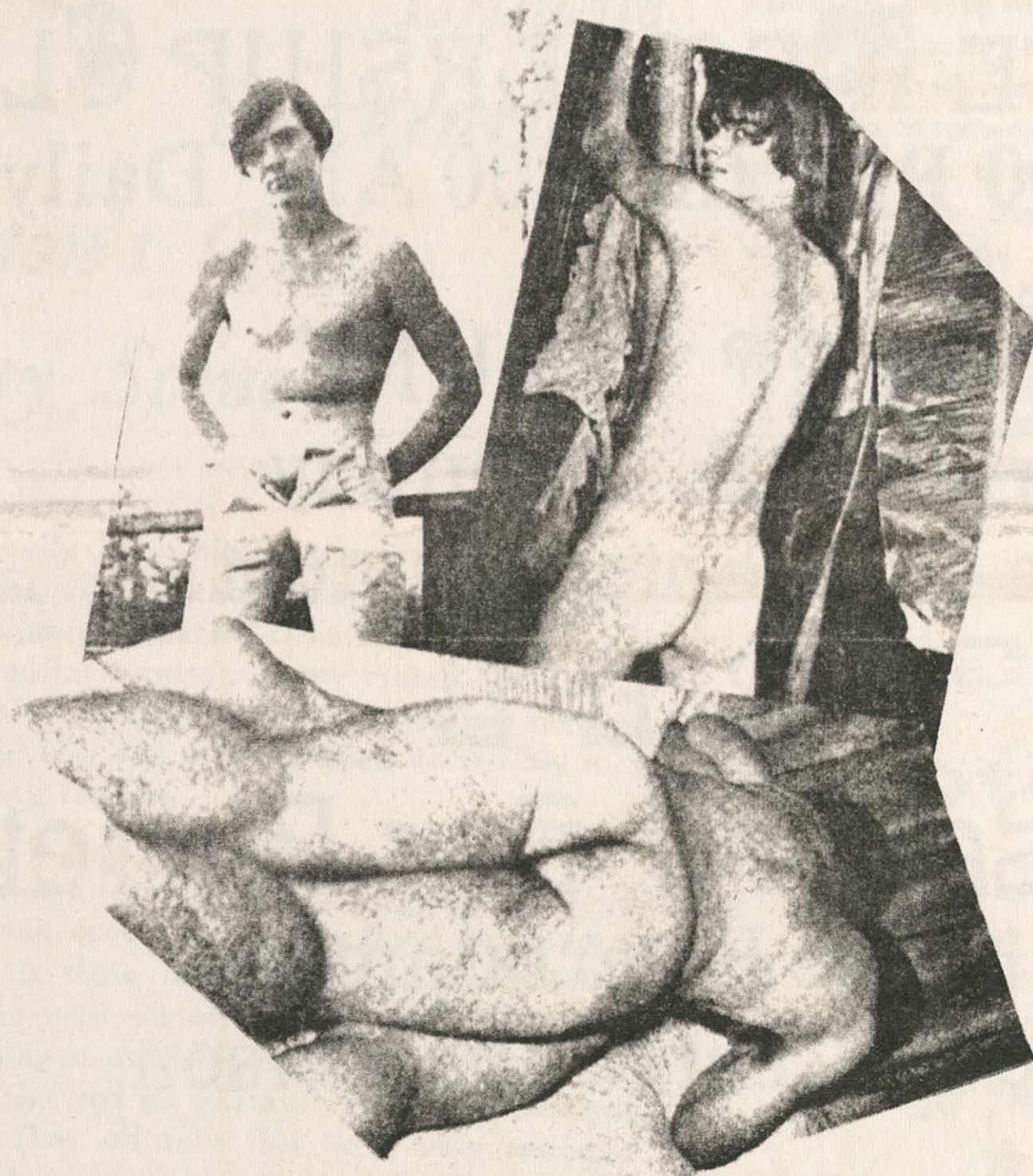

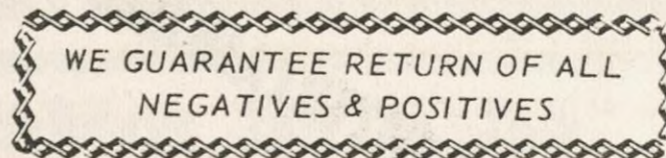

WHAT IS MARIHUANA?

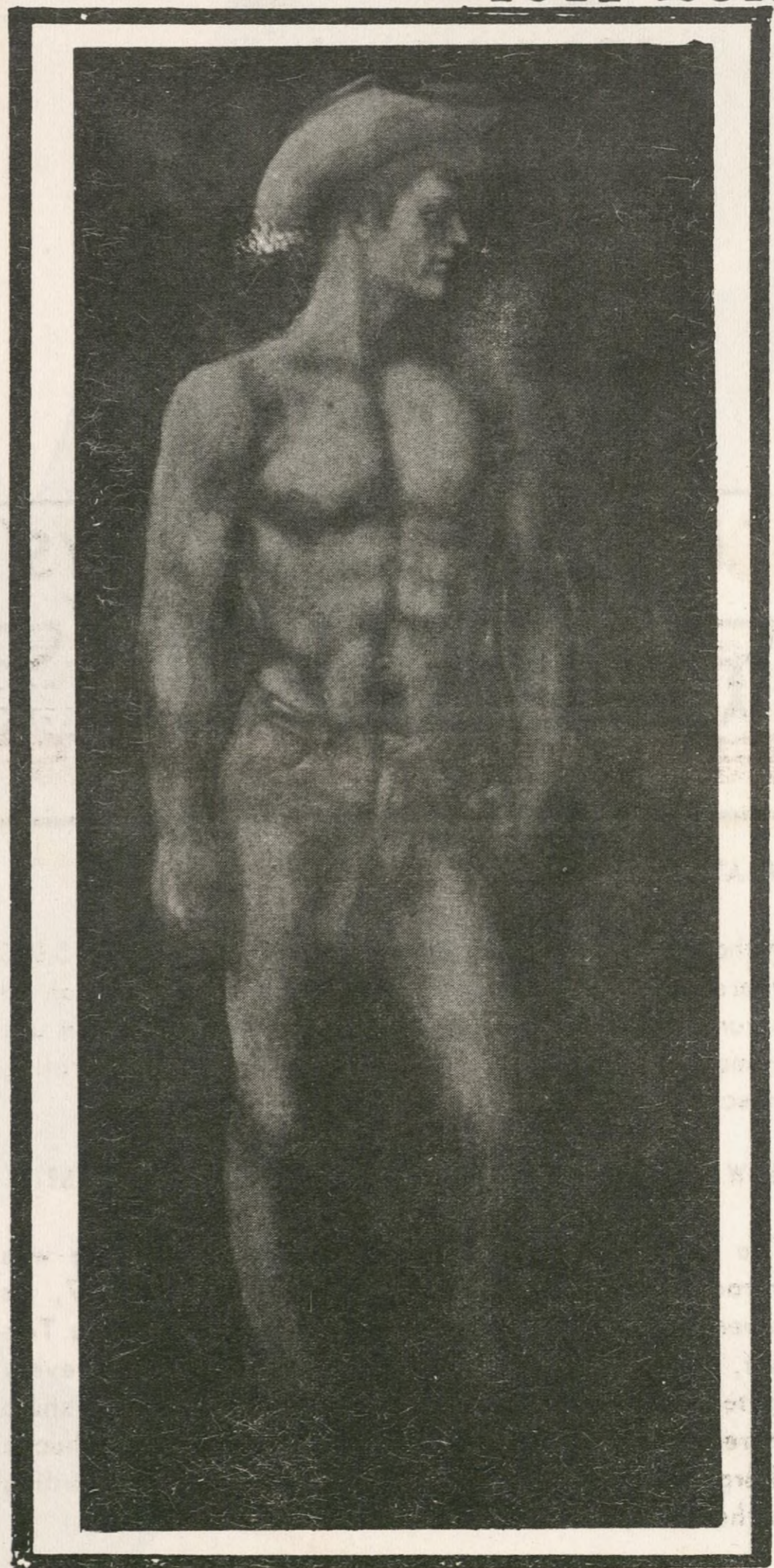
Marihuana is a drug found in the flowering tops and leaves of the Indian hemp plant, *cannabis sativa*. The plant grows in mild climates in countries around the world, especially in Mexico, Africa, India, and the Middle East. It also grows in the United States, where the drug is known as pot, tea, grass, weed, Mary Jane, and by other names.

For use as a drug, the leaves and flowers of the plant are dried and crushed or chopped into small pieces. This green product is usually rolled and smoked in short cigarettes or in pipes, or it can be taken in food. The cigarettes are commonly known as reefers, joints, and sticks. The smoke from marihuana is harsh, and smells like burnt rope or dried grasses. Its sweetish odor is easily recognized.

The strength of the drug differs from place to place, depending on where and how it is grown, how it is prepared for use, and how it is stored. The marihuana available in the United States is much weaker than the kind grown in Asia, Africa, or the Near East.

WHAT IS ITS USE?

Although it has been known to man for nearly 5,000 years, marihuana is one of the least understood of all natural drugs. Unlike other drugs, it has no known use in modern medicine. It is used mainly for its intoxicating effects.

HOW WIDELY IS IT USED IN THE UNITED STATES?

The use of marihuana as an intoxicating drug was introduced in the United States in 1920. In 1937, its general use was outlawed by the Federal Marihuana Tax-Act, followed by strict laws and enforcement in every State. In the mid-1960's, authorities reported a sharp increase in the use of marihuana. Arrests on marihuana charges have more than doubled since 1960, according to the President's Commission on Crime.

HOW DOES THE DRUG WORK?

When smoked, marihuana quickly enters the bloodstream and acts on the brain and nervous system. It affects the user's mood and thinking. Because it may cause hallucinations when taken in very large doses, it is classed as a mild "hallucinogen." Just how the drug works in the body and how it produces its effects have not yet been discovered by medical science.

WHAT ARE THE LAWS DEALING WITH MARIHUANA?

Under federal law, to have, give or sell marihuana in the United States is a felony, which is a serious crime. Federal and many State laws deal with the drug as severely as if it were a narcotic.

The Federal penalty for possessing the drug is 2 to 10 years imprisonment for the first offense, 5 to 20 years for the second offense, and 10 to 40 years for further offenses. Fines of up to \$20,000 for the first or subsequent offenses may be imposed. State laws also control the illicit use of these drugs. For transfer or sale of the drug, the first offense may bring a 5- to 20-year sentence and a fine of up to \$20,000; two or more offenses, 10 to 40 years in prison. If a person over 18 sells to a minor under 18 years of age, he is subject to a fine of up to \$20,000 and/or 10 to 40 years in prison for the first offense, with no suspension of sentence, probation, or parole.

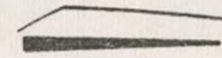

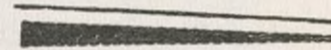

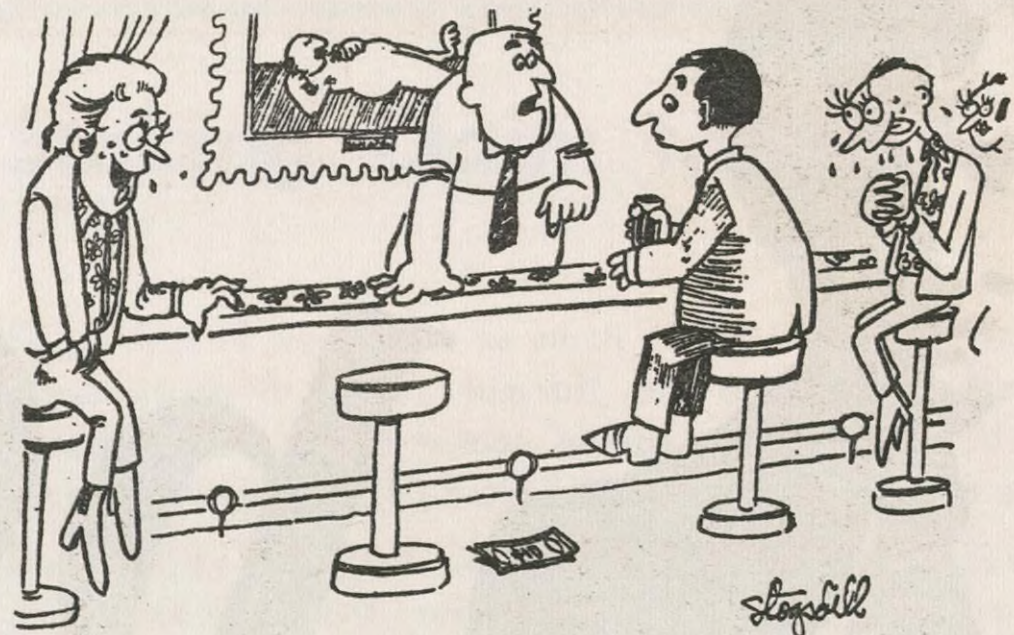

Hints from your Limping Gourmet

Happy Turkey Day, Luves,

I feel sure everyone has their own receipts for their Thanksgiving dinner. Just remember a glass of nice white wine will really make it special.

After the big feast, seems there is always bunches of turkey left over. What to do with it? There is always hash, cold sandwiches and the like which we all know. Here is something different and I know you will like it, give it a try. I call it Turkey Crepes.

Combine 3 cups of diced cooked turkey, 1 can (10½ oz.) condensed cream of mushroom soup, ¼ cup cream. Heat stirring often. Crepes: Whirl in blender 3 eggs, 1 cup milk, 1 cup pancake mix, 2 tablespoons melted butter to texture of cream. Let stand overnight. Butter, preheat a 9" skillet, add ¼ cut batter, tilting pan to spread. Turn when bottom browns. Stack and keep warm. Makes about 6 crepes. Spoon ½ cup turkey filling on center of each crepe and roll. Serve with hot turkey gravy.

Here's a dizzie for cooking a turkey - Mercy!!!!!!!

- 4 cups dry bread crumbs
- ½ cup sage
- ¼ cup onion
- ½ cup uncooked popcorn
- ½ cup celery
- 1 teaspoon salt
- 5 cups broth

Mix well and stuff turkey. Cook in preheated oven at 300 degrees or until popcorn blows the ass off the bird.



Very Loud Music Can Cause Damage to Hearing

If rock 'n' roll recordings were medications they might never pass our FDA because the racket causes deafness.. Dr. Frederick L. Dey of New London, Conn., tested sound pressure levels in a local discotheque and found the octave band frequencies most damaging to hearing.. A typical reading of 110 decibels was obtained at a distance of 30 feet from the loudspeaker.

Noise is measured in decibels. In general, 35 is acceptable in court and classrooms, 55 in restaurants and 60 in sports arenas. At 80 db it is difficult to hear a telephone conversation if the room is noisy. Ninety can be tolerated for only a short time and 100 causes severe physical discomfort. At take-off, jets create 130 db and a mile from the runway 100 decibels.

Admittedly, 110 db in the discotheque is a lot of noise. At this level, exposure lasting an hour or two can be expected to cause some loss of hearing. At first, the impariment is temporary and due to fatigue of the hearing apparatus. But prolonged exposure results in deafness (acoustic trauma). Furthermore, there is ample proof that pop music is damaging the hearing of the present younger generation.

In industry, prolonged exposure to noise (greater than 85 db) is hazardous, even tho susciptible to noise damage varies with the individual. Ringing of the ears (tinnitus) may be an early indication of damage, but regular auditory testing is the only certain way of detecting the condition.

With age, hearing becomes less acute, and if the individual has worked in a fairly noisy environment for many years, he is likely to blame noise for the deficit. Audiometer tests usually distinguish between the two possibilities because different sound levels are involved.

City dwellers find noise pollution almost as disagreeable as air pollution. There is a good possibility that daily exposure has some harmful effect upon hearing.

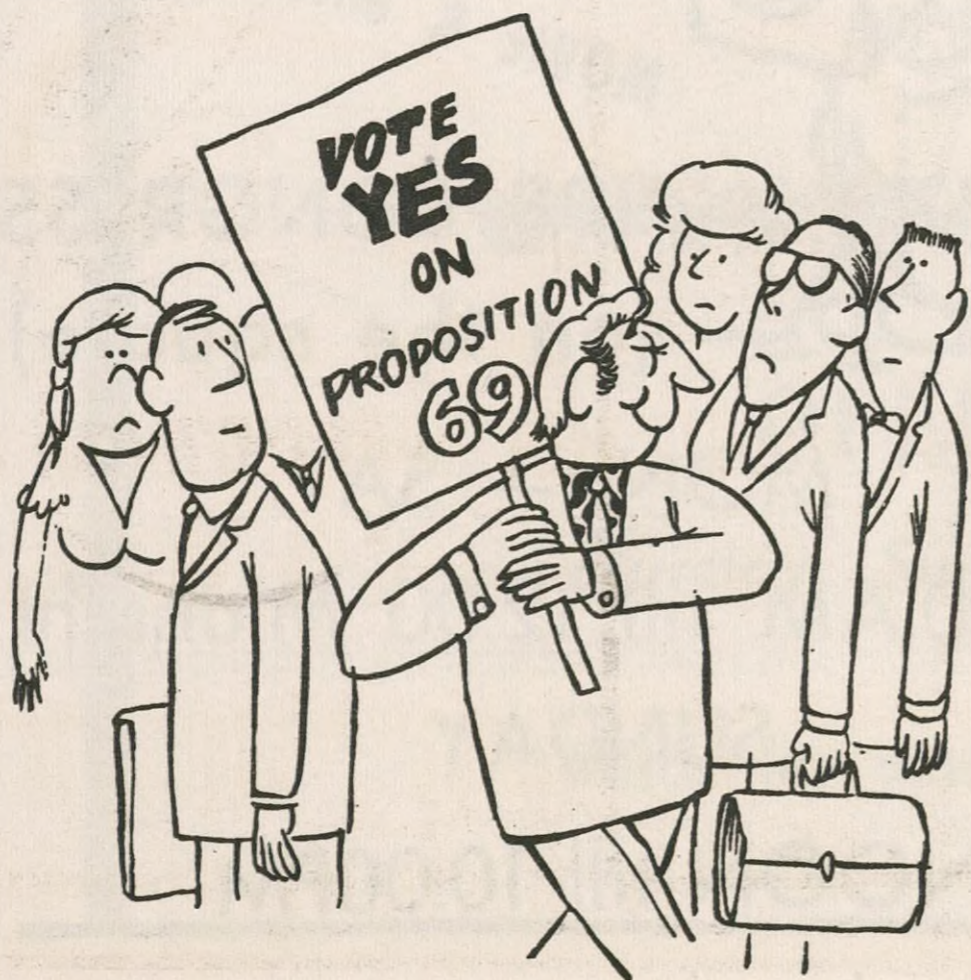
MODEL MAN

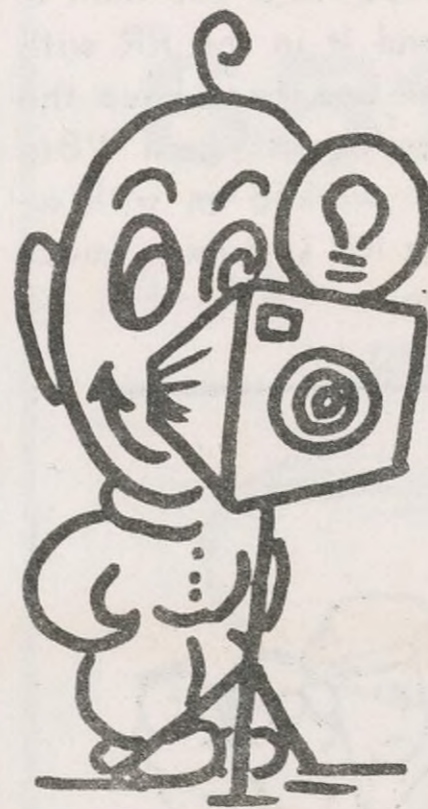

GAYS BUSTED AT PALACE CLUB

The pigs have crapped on the Gay community once again. This time they hoisted their hind leg on the Palace Club. Around 9 pm, Saturday, Oct. 24, two uniformed pigs appeared at the front desk of the club. When they were asked by the desk attendant what their business was, they replied: "Shut up. It's none of your business." All the employees were then searched and IDs were checked. Everyone in the club was asked if he were homosexual.

In the club that evening were two out-of-town guests who were under 21, but accompanied by a member. Their guest cards were stamped "No Alcohol," and they had been served only Coke. They were told by the pigs, who had by this time been joined by eight vice squaders, that unless they confessed to drinking alcohol they would "get the hell beat out of them." One pig, who had been seen in another club by one of the Palace's bartenders, told the bartender, "If you call out my name in front of these guys, I'll knock your teeth down your throat!"

After all the guests and employees had been harrassed and cursed, the two minors and five employees were arrested and taken to jail. On the way downtown, the pigs laughed and joked about "the big haul of queers" they had made. They drove in excess of 110 mph and made numerous threats against their captives.

At police headquarters, four of the victims — including the two minors — were fined and released after one hour. The remaining three Palace employees were held for 17 hours and 20 minutes. They were never told what the charges against them were, were denied use of the telephone, and were never told of their legal rights. While being held, the Palace employees witnessed another prisoner being beaten until "he vomited for an hour."

The owner and manager of the Palace Club proceeded immediately to the police headquarters to post bond and pay fines. When they entered Vice Squad headquarters and asked what they could do to "see that this won't happen again," they were pushed down and told to shut up. One Vice Squad pig told them, "I've had enough of your club, and we're going to have your license."


Release of the employees was secured through a bondsman who was quoted as saying, "This is the most obvious case of police harrassment I've ever seen." Bonds on the three employees held over night were set at \$800 each — but they were never told what the charges were.

The headline of the October issue of Nuntius, which bills itself as Texas' Gay Newspaper, reads: "No Police Harrassment in Houston." The Nuntius claims that the police are to help better run and protect our bars and that we should cooperate fully with them. We say Bullshit. The pigs are the enemy of the Gays. The incident at the Palace is not a remote one, not a rare one. It is an everyday occurrence in the Montrose area.

It's time the Gay community woke up to the facts, and it's time the Nuntius and others who claim to speak for Gays stopped avoiding the truth about the Houston police. The pigs have declared war on the Montrose area, and the Gay community is part of the Montrose.

The Gay Liberation Front of Houston is dedicated to the building of an effective defense within the Gay community — a defense capable of repelling the pigism that rocked the Palace Saturday night, the pigism that fucks over Gays every day of our lives. We call on all the Gays of Houston to join in the battle for Gay equality and dignity.
